RE: ACCEPT ALL BIDS-2019 LIQUID BITUMINOUS MATERIAL AND ASPHALT MIX-ENGINEER




WHEREAS, bids were received on March 12, 2019 for liquid bituminous material and asphalt mix materials and

WHEREAS, all bids have been reviewed by the Logan County Engineer, Scott C. Coleman and he has made a recommendation to accept all bids received.

THEREFORE, BE IT HEREBY RESOLVED by the Logan County Board of Commissioners to accept all bids received from Asphalt Materials, K-Tech Specialty, Terry Asphalt Materials, Shelly Materials, and authorize the Engineer to buy from the lowest bidder for each grade of the material, and to purchase product from an alternate bidder, if the low bidder is unable to supply the product on any given day and time.

Gentlemen:

I have reviewed the bids received on March 12, 2019, for the above captioned materials shown on our bid specifications. Attached is a tabulation of the bids received by your honorable board. I offer the following comments concerning the bids:

1. Asphalt Materials is low bidder on MWS-90 and HFRS-2P.
2. K-Tech Specialty Coatings is low bidder on Fog Seal (QF-40 or Equal).
3. Terry Asphalt Materials was not low on any items.
4. Shelly Materials is low bidder on 301, 448-T1 and 448-T2 Hot Mix.

In view of the above, I recommend that your honorable board accept all of the bids, authorizing us to buy from the lowest bidder for each grade of the material, and to purchase product from an alternate bidder, if the low bidder is unable to supply us with material on any given day and time. This will allow us flexibility, depending on material and aggregate to be used on various projects.

These materials will be purchased from Auto and Gas Funds.

In accordance with ORC 9.24, we have checked the Auditor of State's Unresolved Findings for Recovery Database and the federal system for awards management. All companies that bid were not listed and we have retained the certified search confirmation page in the project file.
