SPECIAL HAULING PERMIT

A special hauling permit is required for moving a vehicle, object or structure exceeding the maximum size or weight as specified in Section 5577.01 to 5577.09 of the Ohio Revised Code. This application and permit is issued in accordance with Ohio Revised Code Section 4513.34.

This permit is valid for only County and Township roads in Logan County. An electronic or physical copy of this validated permit must be carried in the vehicle or combination of vehicles to which it refers and shall be open to inspection by any authorized agent of the County Commissioners. No person shall violate any of the terms of this permit.

The mover agrees that any minor damage to drainage structures or to the asphalt surface of the road from rutting, pick up of asphalt, or damage by the tires of the vehicle will be repaired by the County and billed to the mover by the County. The mover agrees to pay the necessary repair cost. The mover agrees that anything other than minor damage will be repaired by the mover, as approved by the Logan County Engineer, at the mover's expense. The temporary and permanent repairs shall be made by the mover as soon as reasonably possible.

The mover agrees to move during daylight hours and to protect the traveling public with the necessary flagmen, flags, lights, etc., and at all times indemnify and save harmless Logan County against all damages that may occur through the use of this permit.

Permit applications must be submitted at least 72 hours (excluding weekends and holidays) before moving.

Fee requirements waived for federal, state and local governments, and any political subdivisions thereof, for moving their equipment but said entity still needs to pay applicable fees if hauling overweight due to hauling overweight material.

Single Trip Provides for one movement of one vehicle and load(s) over one specific route. Special provisions such as signage, escorts, etc. will be specified in the permit.

Round Trip Provides for one movement of a specific vehicle and load(s) over one specific route and a return trip with the same vehicle and load(s) over the same route.

Late Fee If you have a move with a desired effective permit date less than 72 hours (excluding weekends and holidays) from the time the application was submitted, the Logan County Engineer may be able to process said permit application and if said application is processed a late fee of \$50 will be charged to the applicant.

Continuous Permit The County Engineer will consider a 12-month maximum permit length. If approved, fees for a continuous permit will be generally based upon the estimated number of trips with the final continuous fee determined by the Logan County Engineer. Enter your continuous permit length request (in months) and state the estimated number of trips for the entire permit length under 'Special Request Note' on page 2 of this application.
