

LEGAL DESCRIPTION FOR A 3.839 ACRE PARCEL

Being a parcel of land situated in Virginia Military Survey 3683, Jefferson Township, City of Bellefontaine, Logan County, Dhio.

Being out of the Harold Marker original 79.74 acre tract as deeded and described in Deed Book Volume 344, Page 861 of the Logan County Records of Deed and being more particularly described as follows;

Beginning at a railroad spike found on the south line of the Virginia Military Survey 3863, on the City of Bellefontaine Corporation Line and at the intersection of the centerlines of Township Road 55 (60' R/W) and Sloan Boulevard (80' R/W);

THENCE, with the centerline of Sloan Boulevard, (80 feet wide), N 04° 42′ 22″ W, a distance of 361.67 feet to a MAG nail found at the P.C. of a curve;

THENCE, N 85° 17′ 38" E, a distance of 40.00 feet to a 5/8 inch iron rod found on the east right-of-way of Sloan Boulevard;

THENCE, with the east right-of-way of Sloan Boulevard and the west line of the Don M. & Margaret Hilliker Young Men's Christian Association 8.602 acre tract, (D.R. 423, Pg. 608), a curve to the left having a central angle of 22° 51′ 51″, a radius of 430.00 feet, an arc length of 171.59 feet and a chord bearing N 16° 08' 17" W, a distance of 170.46 feet to a concrete monument set at the southwest corner of Lot Number 5040 of the Sloan Boulevard Professional Park - Phase I as recorded in Plat Cabinet B, Slides 71B-72A;

THENCE, with the east right-of-way of Sloan Boulevard and the west line of the said Sloan Boulevard Professional Park - Phase I, a curve to the left having a central angle of 17° 23′ 37", a radius of 430.00 feet, an arc length of 130.54 feet and a chord bearing N 36° 16′ 02″ W, a distance of 130.04 feet to a concrete monument set;

THENCE, continuing with the east right-of-way of Sloan Boulevard and said Professional Park, N 44° 57′ 52" w a distance of 436.04 feet to a concrete monument set marking the PDINT DF BEGINNING, said point being the northwest corner of lot number 5046 of said Professional Park;

THENCE, continuing with the east right-of-way of Sloan Boulevard N 44° 57′ 52″ W, a distance of 663.74 feet to a concrete monument set;

THENCE, with the south line of the Board of Education of the Ohio Hi-Point Joint Vocational School District is original 100.00 acre tract, (Vol. 389, Pg. 568), N 84° 53′ 05″ E, a distance of 116.45 feet to a 1 inch iron pipe found;

THENCE, with the south line of the Board of Education Dhio Hi-Point Vocation-Technical Center School District original 52.54 acre tract, (Vol. 341, Pg. 733), N 85° 00′ 00″ E, a distance of 438.04 feet to a concrete monument set;

THENCE, with the west line of the United Telephone Company original 20.00 acre tract, (Vol 283 Pg 161), and the Corporation line of the City of Bellefontaine, S 05° 15′ 21″ E, a distance of 400.06 feet to a concrete monument set;

THENCE, with the northwest line of said Sloan Boulevard Professional Park - Phase 1 S 45° 02′ 08" W, a distance of 169.54 feet to the point of beginning.

Containing 3.839 acres.

The basis for bearings is the centerline of the westbound lanes of U.S. Route 33, being N 44° 57′ 00″ W, and all other bearings are from angles and distances measured in a field survey by Kusmer and Associates, Inc. in April, 2001.

THE UTILITY EASEMENTS INDICATED ON THIS PLAT ARE FOR THE ERECTION, CONSTRUCTION MAINTENANCE, REPAIR AND INSTALLATION OF ANY OR ALL UTILITIES, BOTH PUBLIC AND PRIVATE, FOR USE WITHIN SLOAN BOULEVARD PROFESSIONAL PARK-PHASE 2. IT SHALL BE LAWFUL FOR ANY SUCH UTILITY, PUBLIC OR PRIVATE, OR ITS EMPLOYEES OR REPRESENTATIVES OR ANYONE ACTING FOR ANY SUCH UTILITY TO ENTER UPON SAID EASEMENT OR RIGHT-OF-WAY AT ANY TIME FOR THE PURPOSE OF CARRYING OUT THE OBJECTIVES FOR WHICH SUCH EASEMENTS OR RIGHTS-OF-WAY WERE RESERVED. NO STRUCTURES OR PLANTINGS ARE PERMITTED WITHIN ANY UTILITY EASEMENT.
