

The Mosier Allotment

I hereby certify that the annexed plat correctly represents a Subdivision made by me of the following described land.

Situate in the County of Logan and State of Ohio and in the township of Washington, and described as follows: Being a part of the northeast quarter of section 35, town of Range 5, beginning at a limestone marked with an 'X' at the southeast corner of said quarter section; thence N 1/2° W with the section line 890 feet; thence N 89° 40' W 257 feet to a stake in the east side of an alley, said stake being the beginning point of this survey; thence continuing N 89° 40' W 932 feet to a stake from which a stake in the east line of The Ohio Electric Railway bears S 15° 30' W 214 1/2 feet; also center of 4 Willows; S 43° W 57 feet; thence N 16° E 647 feet from which an Elm tree 12 inches in diameter bears N 69° W 119 1/2 feet; thence S 75° 3/4° E along the line of the State land with the south bank of the Reservoir 654 feet to the northwest corner of a lot of land sold by J.D. Tam et al to William Woerner; thence in a southerly direction along the west line of said Woerner's land 187 feet to the south side of a 10 foot alley 30 feet to the northwest corner of another tract of land owned by William Woerner; thence in a southerly direction with Woerner's West line 50 feet to his southwest corner; thence in an easterly direction with his southline 79 1/2 feet to a log in said line his southeast corner; thence in a southerly direction 257.3 feet to the beginning

All distances are marked in figures denoting feet and the decimal parts thereof. — In future surveys the East and South lines shall be used as a base. Each Block to receive its exact quantity as shown herein. The surplus or shortage shall fall on the North and West Blocks. — All Lanes and Alleys herein shown, are hereby dedicated to the public use forever. William Woerner enters into this dedication so far as it may relate to a strip of land 15 feet in width taken off of the East side of his lot for highway purposes and the same is hereby dedicated by him for the uses and purposes herein expressed.
