ENGINEER'S CERTIFICATE

I William H. Lewis do hereby certify the annexed Plat is a true representation of Fernwood Number Four as surveyed by me in April 1956. The said Subdivision is part of W.M.S. 13393 and is located in Richland Township, Logan County, Ohio.

All dimensions on the plat are in feet and decimals of a foot. "Δ" is used to represent the central angle; "R" the radius; "C" the chord; "T" the tangent. "⊙" Indicates State Highway Monuments found. "o" Indicates iron pipes found. "•" Indicates the iron pipes set & "u" Indicates 2"x2"x24" wooden stakes set. The area contained within the plat is 2.50 acres. The plus & minus distances shown are from the iron pipe to the present shore line.
