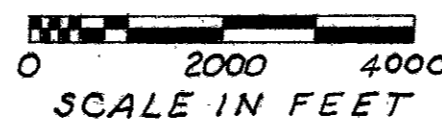




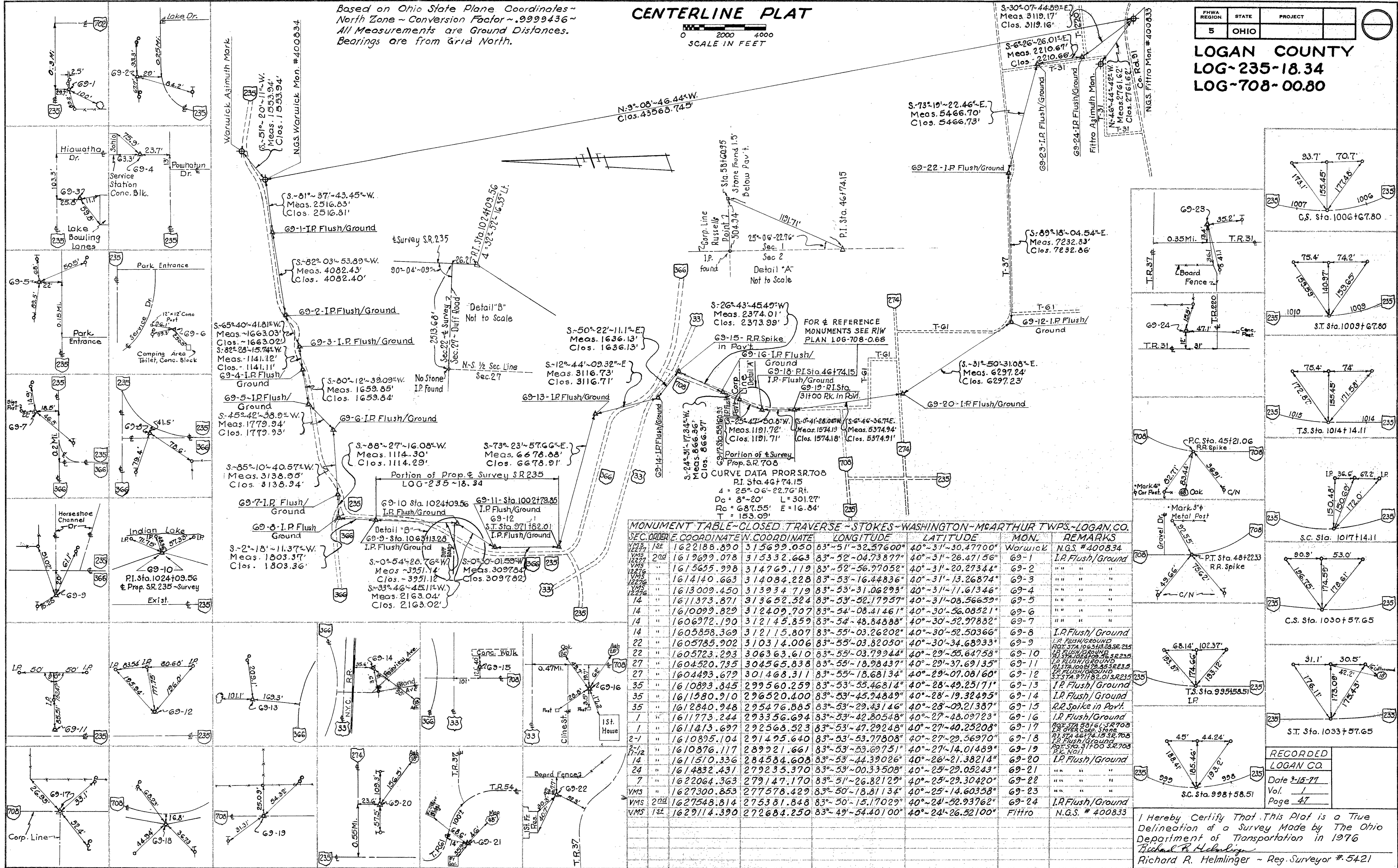

### CENTERLINE PLAT



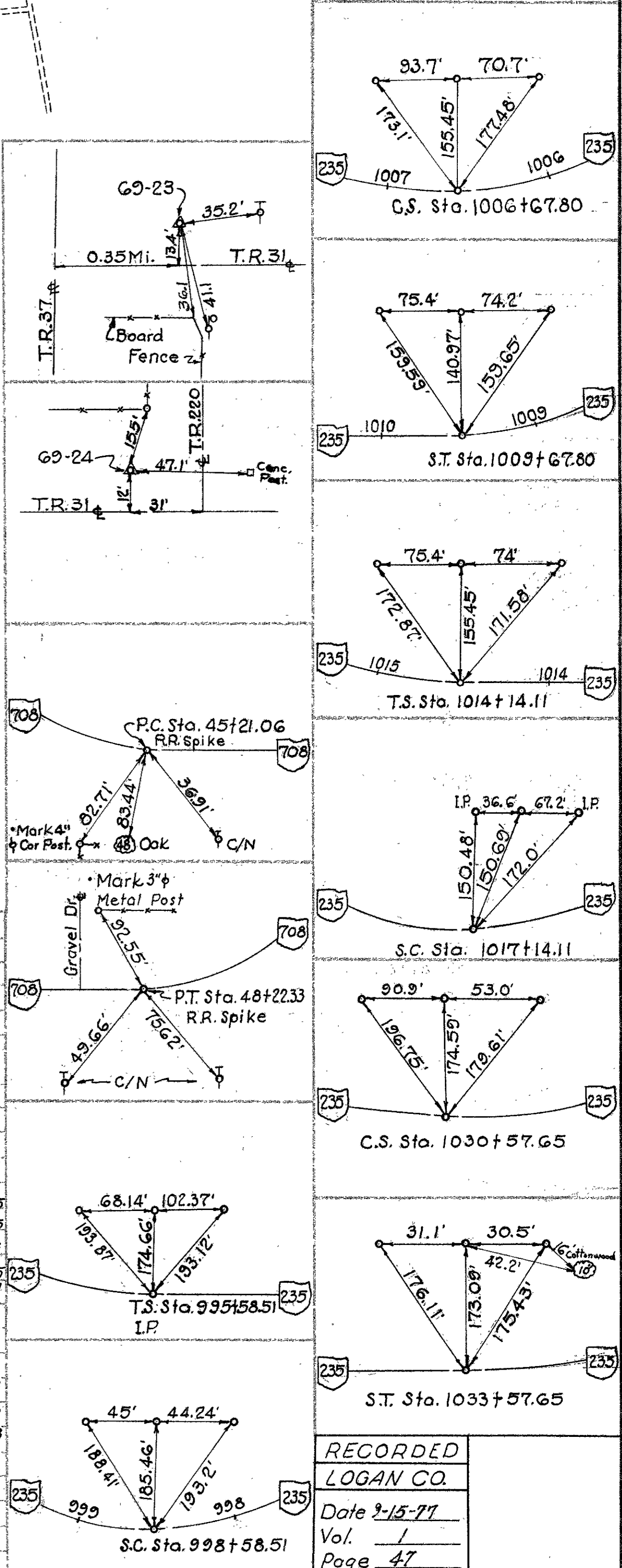

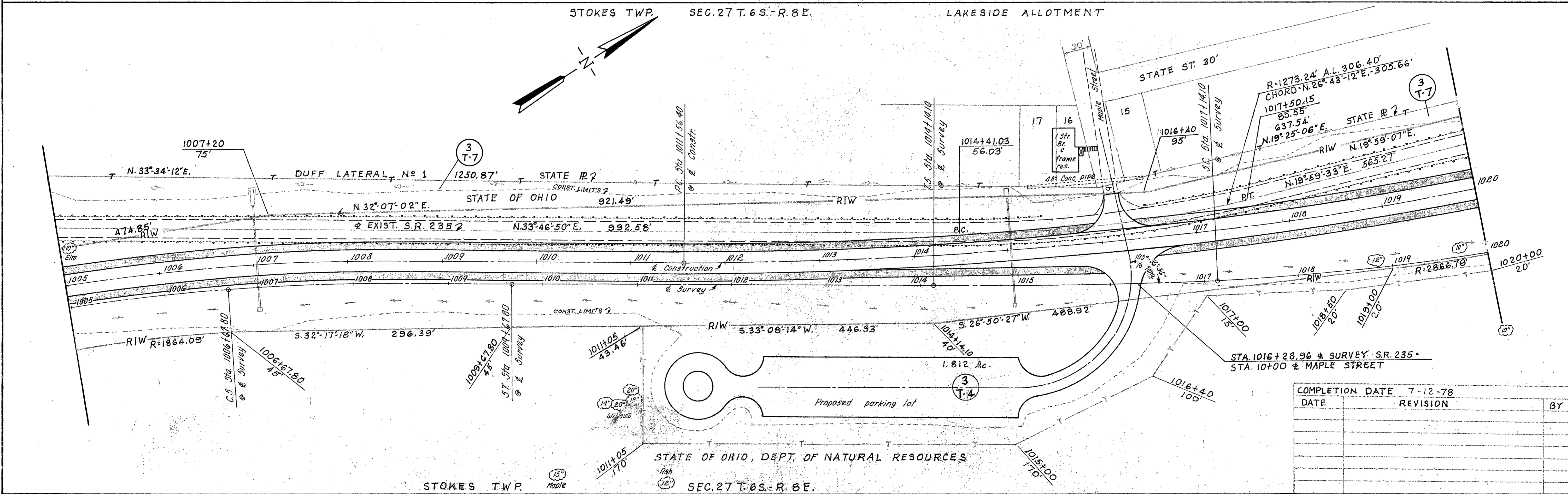
RIW PLAN - S.R. 235 STA. 968+35.27 TO STA. 990+00 & S.R. 366 APPROACH
