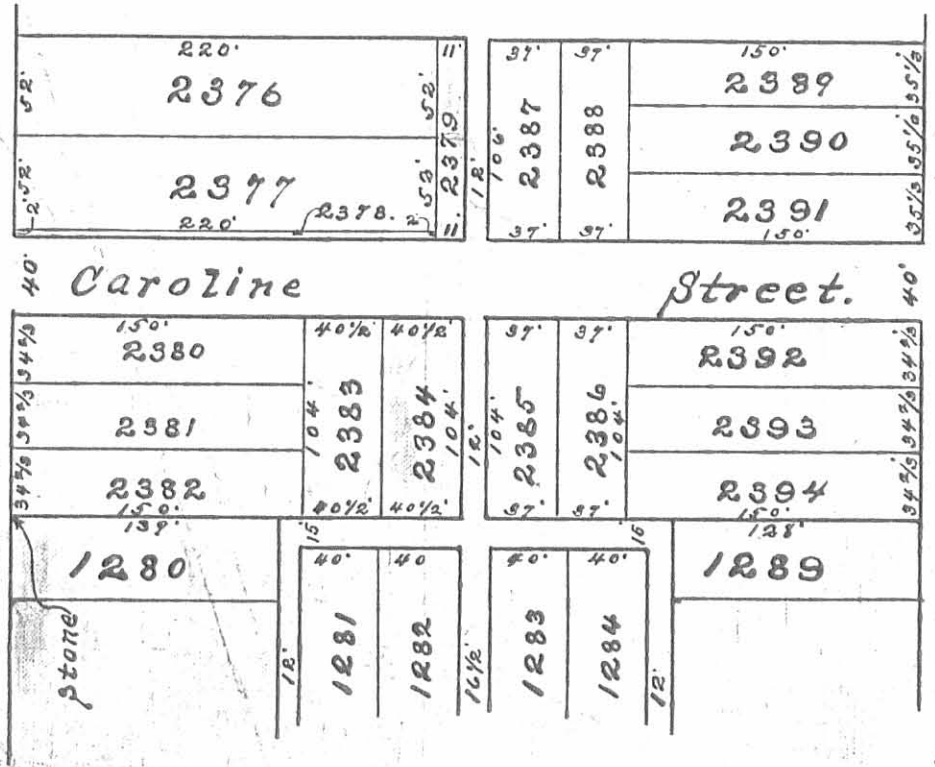
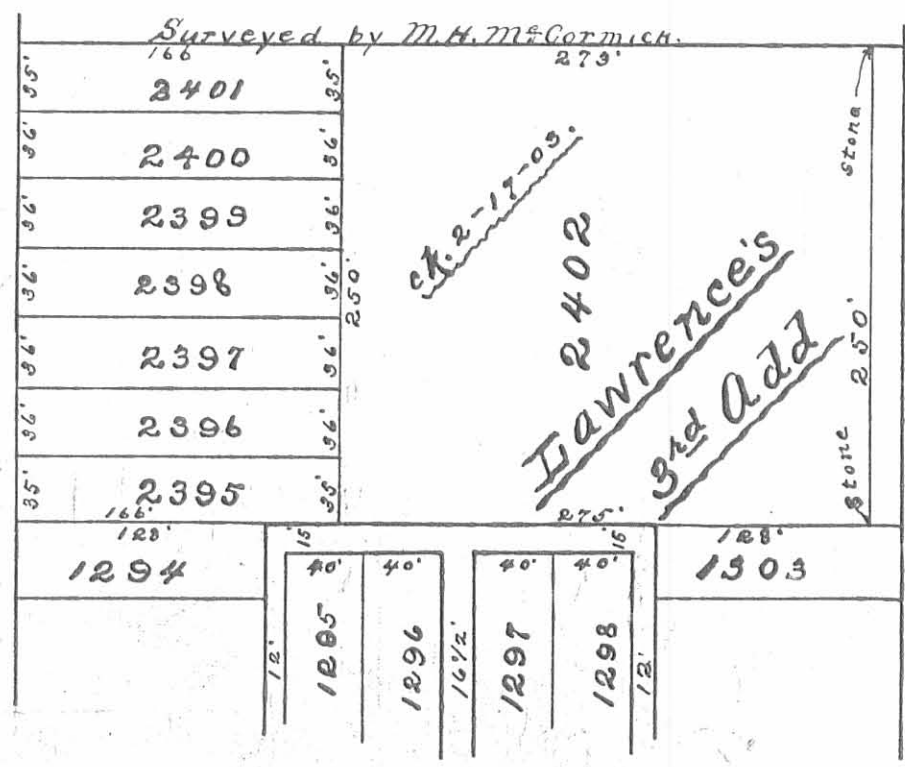

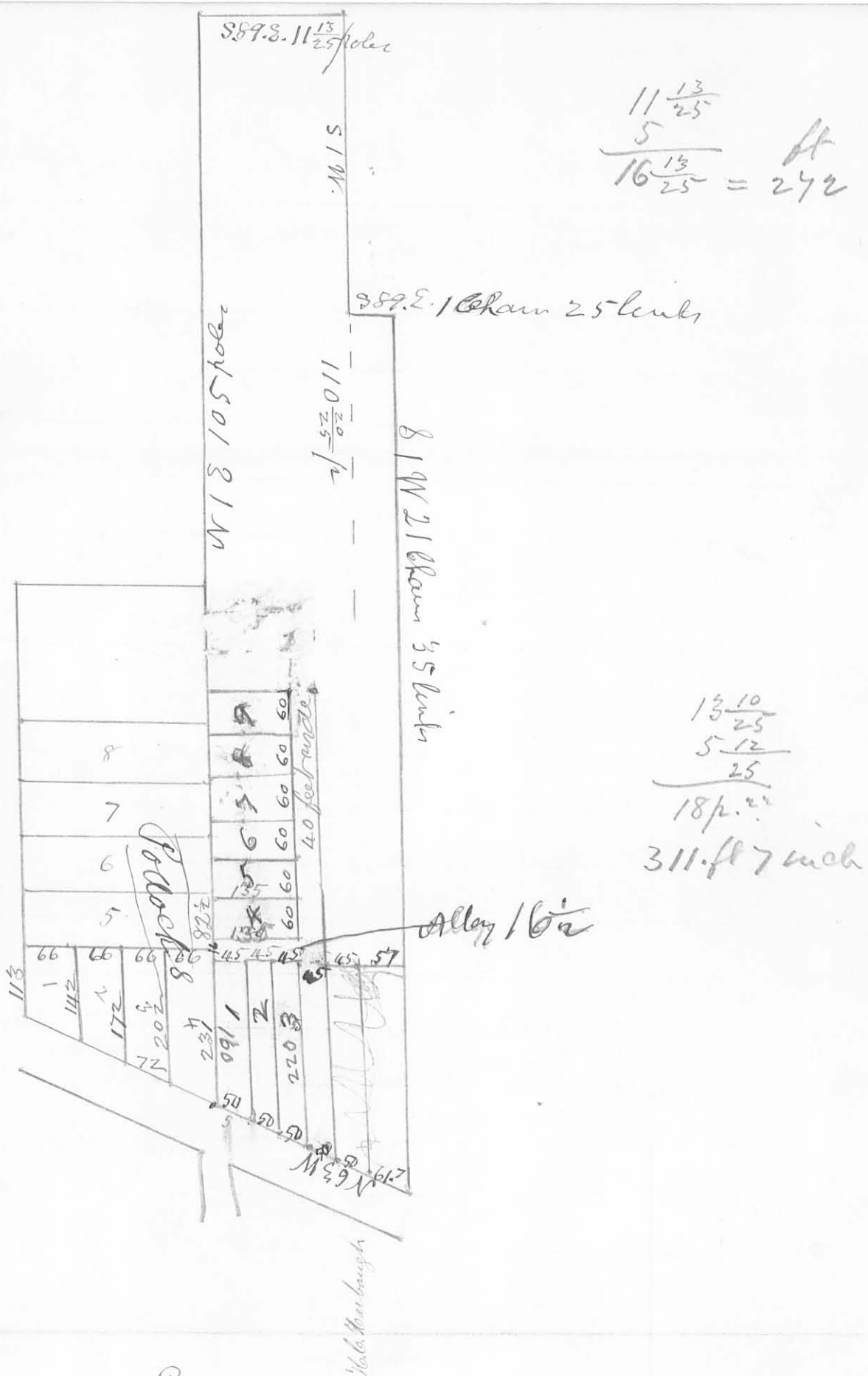

See deed from Joseph Lawrence to Joseph Lawrence 30 Sept 1862 Vol 38 p. 403-4

In Logan County Ohio. Part of Fractional section Number (35) thirty five Township Number four (4) Range (14) fourteen M.R.S. beginning at a stake North East corner to land formally owned by Sebastian Keller and in the line of Isaac S. Gardners land and in his South line: Thence South 89 degrees East Eleven and $\frac{13}{25}$ poles to a stake: thence south one degree West $110\frac{20}{25}$ poles to a stake in the Lima road: Thence with the Lima road North 63 degrees West $13\frac{13}{25}$ poles to a stake: Thence North one degree East 105 poles to the beginning containing Eight acres more or less. Also $2\frac{63}{100}$ Acres more or less bounded as follows. Beginning at a stone South west corner to about 5 acres of land conveyed by Henry Royer & wife to John Miller by deed dated August 1st 1846: Thence with Millers South line South 89 degrees East one chain and twenty five links to a stone: Thence South one degree West 21 chains and 35 links crossing a ~~on~~ small run at 50 links and a pond at 20 chains to a stone in the Lima road Thence with said road north 63 degrees West one chain and 37 links to a stone: thence North one degree East 20 chains and 76 links to the beginning Said lands are the same conveyed to Joseph Lawrence by Fealding Bedow & wife by Daniel S. Wrightman & wife.
