Surveyors Certificate

The annexed plat represents correctly  
J. S. Gardner's 5<sup>th</sup> Addition to  
Bellfontaine Ohio; as surveyed by the  
undersigned during the months of  
March and April 1891.

The dimensions are shown on the  
map in feet and inches, the bearings  
are magnetic. The lines of the streets  
are located as follows: The lines of  
Gardner Avenue and Elm Street by  
producing the center lines of the 30 foot  
Street of the original town; The line  
of High Street by producing the center  
line of High Street as a forty foot  
Street in the old town; and the center  
lines of Williams and Walnut Streets  
as laid out on this plat. A stone  
6" x 6" x 32" with a hole drilled in the  
center of the top is placed at each inter-  
section of the above mentioned lines  
as shown on the map.
