HEYDINGER SURVEY

The following described real estate situated in the State of Ohio, County of Logan, Township of Lake, being part of Lot 2480 in Hamilton Allotment in the City of Bellefontaine, and more particulalry described as follows:

Beginning at a 1 $\frac{1}{4}$ inch iron pipe found at the southeast corner of Lot 2481 in said Hamilton Allotment, in the north line of Indian Park Addition Nos. 3 and 4.

Thence with the east line of said Lot 2481 N. 50° 05' 20" W. 138.40 feet to a 5/8 inch iron bar set.

Thence N. 38° 11' 00" E. 115.92 feet to a 5/8 inch iron bar found in the west line of Lot 2479 of said Hamilton Allot.

Thence with said west line S. 50° 05' 20" E. 140.78 feet to a 5/8 inch iron bar found in the north line of said Indian Park Add. 3 and 4.

Thence with said north line S. 39° 21' 29" W. 115.92 feet to the place of beginning.

Containing 0.371 acre more or less.




