The following described real estate situated in the State of Ohio, County of Logan, Township of Lake, being part of Virginia Military Survey 4990 in the City of Bellefontaine and more particularly described as follows:

Beginning at a 5/8 inch iron bar set in the east right-of-way line of Hayes Street at the northwest corner of Betty Young's 0.15 acre tract as described in D. B. Vol. 374 Page 693, said iron bar being NORTH 301.30 feet from a 5/8 inch iron bar found at the intersection of the right-of-way lines of Hayes Street and Columbus Avenue.

Thence with the right-of-way line of said Hayes Street NORTH 43.90 feet to a 5/8 inch iron bar set at the southwest corner of Dorothea Heil's 0.16 acre tract as described in O. R. Vol. 133 Page 834.

Thence with said Heil's south line S. 89° 28' 00" E. 170.00 feet to a 5/8 inch iron bar set in the west line of Eric Nelson's 1.7 acre tract as described in D. B. Vol. 389 Page 105.

Thence with said Nelson's west line SOUTH 44.00 feet to a 5/8 inch iron bar set at said Betty Young's northeast corner.

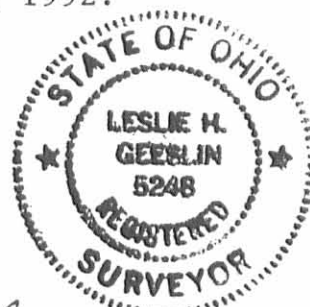
Thence with said Young's north line N. 89° 26' 00" W. 170.00 feet to the place of beginning.
