The following description describes a parcel of real estate owned by Consolidated Rail Corporation (Conrail), formerly the Cincinnati, Sandusky, and Cleveland Railroad Company. Said real estate is located in both Harrison and Lake Townships, Logan County, Ohio. Part of the above mentioned real estate is found within the City of Bellefontaine, and is part of Sec. 5-T. 3-R. 14, Sec. 6-T. 3-R. 14, and Sec. 35-T. 4-R. 14. The above mentioned parcel is more particularly described as follows:

Beginning at a stone found at the N.W. corner of the S.W. quarter of Section 6-T. 3-R. 14. Said stone marks the intersection of Logan County Road No. 13 and Logan County Road No. 32, and is shown as being Station 186+83.49 on a 1962 route survey of Logan County Road No. 32 (Road file - Logan County Engineers Office).

Thence with the center line of Logan County Road No. 32 and the West line of Section 6-T. 3-R. 14, S. 4°-13'-54" W., 1694.60 feet to a railroad spike set. Said railroad spike set is the true point of beginning for this description.

Thence with the West line of the Logan County Commissioner's 0.16 acre tract (D.B. Vol. 139; pg. 143), Thomas E. O'Connor, Jr. et ux's 73.39 acre tract (D.B. Vol. 354; pg. 306), Algay R. Tackett et ux's 8.84 acre tract (D.B. Vol. 190; pg. 244), Olive M. Aikin's 0.36 acre and 21.27 acre tracts (D.B. Vol. 240; pg. 589), and Orlie R. Close et ux's 29.17 acre tract (O.R. Vol. 59; pg. 7), S. 33°-32'-05" E., 3424.62 feet to a 5/8 inch diameter capped re-bar set. The above described line passes through a 5/8 inch diameter capped re-bar set on the East right-of-way line of Logan County Road No. 32 at 48.98 feet.

Thence 2597.32 feet with a transitional curve to the left to a 5/8 inch diameter capped re-bar set (Length of spiral=200 feet, spiral angle=0°-16'-35", Delta=22°-43'-10", Delta of curve=22°-10'-00", Radius of curve=5679.58 feet). The long chord of said transitional curve bears S. 44°-53'-40" E., and is 2575.94 feet in length. Said curved line being the West line of Orlie R. Close etux's 29.17 acre tract, Tom L. Taylor's 14.83 acre tract (D.B. Vol. 388; pg. 537), June Shick etvir's 23.61 acre tract (D.B. Vol. 394; pg. 409), Edward D. Huffman etux's 7.36 acre tract (O.R. Vol. 145; pg. 842), and Diane L. Oliver's 5.08 acre tract (D.B. Vol. 98; pg. 570). The above described curved line passes through two 5/8 inch diameter capped re-bars set on the S.C. and C.S. at 200 feet and 2397.32 feet respectively.

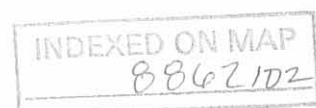
Thence S. 56°-15'-15" E., 595.87 feet to a 5/8 inch diameter capped re-bar set at the S.W. corner of William C. Armstrong etux's 0.13 acre tract (D.B. Vol. 43; pg. 512). The above described line being the West line of Diane L. Oliver's 5.08 acre tract, Eleanor Louise Meeker's 0.62 acre tract (D.B. Vol. 60; pg. 262), and William C. Armstrong etux's 0.13 acre tract.

Thence with the South line of Armstrong's 0.13 acre tract, N. 26°-49'-24" E., 24.70 feet to a 5/8 inch diameter capped re-bar set on the West right-of-way line of Garfield Avenue.

Thence with the West right-of-way line of Garfield Avenue, S. 17°-07'-37" E., 43.77 feet to a 5/8 inch diameter capped re-bar set.

Thence continuing with the West right-of-way line of Garfield Avenue, S. 54°-41'-05" E., 244.33 feet to a 5/8 inch diameter capped re-bar set at the N.W. corner of Norbert J. Wagner etux's 0.33 acre tract (D.B. Vol. 293; pg. 244).

Thence with the West line of Wagner's 0.33 acre tract, S. 35°-18'-55" W., 32.35 feet to a 5/8 inch diameter capped re-bar set on the S.W. corner of Wagner's 0.33 acre tract.



Thence with the South line of Wagner's 0.33 acre tract, S. $55^{\circ}-57'-32''$ E., 1082.16 feet to a railroad spike set on the center line of West Street. The above described line passes through three $5/8$ inch diameter capped re-bars set on the West line of Troy Road, the East line of Troy Road, and the West line of West Street at 528.18 feet, 568.35 feet and 1059.34 feet respectively.

Thence with the center of West Street, S. $5^{\circ}-16'-09''$ W., 39.74 feet to a railroad spike set.

Thence with the North line of the former T. & O. C. Railroad, N. $56^{\circ}-15'-15''$ W., 881.53 feet to a $5/8$ inch diameter capped re-bar set. The above described line passes through three $5/8$ inch diameter capped re-bars set on the West line of West Street, the East line of Troy Road, and the West line of Troy Road at 22.75 feet, 511.82 feet, and 551.88 feet respectively.

Thence continuing with the North line of the former T. & O. C. Railroad, 342.93 feet with a curve to the left to a $5/8$ inch diameter re-bar set. Said curve has a radius of 3384.41 feet, and a central angle of $5^{\circ}-48'-20''$. The long chord of said curve bears N. $59^{\circ}-09'-25''$ W., and is 342.78 feet in length.

Thence with the North line of Inland Products, Inc.'s 14.25 acre tract (D.B. Vol. 196; pg. 430), N. $56^{\circ}-15'-15''$ W., 119.41 feet to a $5/8$ inch diameter capped re-bar set on the North line of the former T. & O. C. Railroad.

Thence continuing with the North line of the former T. & O. C. Railroad, N. $25^{\circ}-56'-12''$ E., 3.84 feet to a $5/8$ inch diameter capped re-bar set.

Thence continuing with the North line of the former T. & O. C. Railroad, 27.25 feet with a curve to the left to a $5/8$ inch diameter capped re-bar set. Said curve has a radius of 3402.41 feet and a central angle of $0^{\circ}-27'-32''$. The long chord of said curve bears N. $64^{\circ}-17'-33''$ W., and is 27.24 feet in length.

Thence continuing with the North line of Marian A. Idle's 111.675 acre tract, N. $56^{\circ}-15'-15''$ W., 281.30 feet to a 5/8 inch diameter capped re-bar set.

Thence 2639.88 feet with a transitional curve to the right to a 5/8 inch diameter capped re-bar set (Length of spiral=200 feet, spiral angle= $0^{\circ}-16'-35''$, Delta= $22^{\circ}-43'-10''$, Delta of curve= $22^{\circ}-10'-00''$, Radius of curve=5789.58 feet). The long chord of said transitional curve bears N. $44^{\circ}-53'-40''$ W., and is 2618.23 feet in length. Said curved line being the North line of Marian A. Idle's 111.675 acre tract and Wilma F. Buroker's 66.42 acre tract (O.R. Vol. 60; pg. 623). The above described curved line passes through two 5/8 inch diameter capped re-bars set on the S.C. and C.S. at 200 feet and 2439.88 feet respectively.

Thence with the North line of Wilma F. Buroker's 66.42 acre tract, N. $33^{\circ}-32'-05''$ W., 691.83 feet to a 5/8 inch diameter capped re-bar set.

Thence N. $57^{\circ}-39'-37''$ E., 10.00 feet to a 5 inch square concrete post found passing a 5 inch square concrete post at 1.30 feet.
