Terrill Survey.

The following described land being in V.M.S. 9978 and being in Rushcreek and Bokescreek Townships, Logan County, Ohio.

Beginning at an iron in the center of a road known as Road No. 115 said iron being on the line between Logan and Hardin Counties; thence with the center of said road S.10° 28' E. 1777 feet to an iron pipe, said pipe being the S.E. corner of a tract of land owned by Clay Lease and said iron being the beginning point of this survey; thence with the center of said road S.10°28' E. 762.0 feet to a wooden stake at the N. right-of-way line of C.C.C. & St. L.R.R. thence with the North right-of-way fence of said R.R. S.62° 46' W. 1218.0 feet to a concrete post marked Rushcreek - Bokescreek and said ~~point~~^{post} being the line between the two Townships; thence continuing with said right-of-way fence S.62°-46' W. 1800.0 feet to a concrete brace post in H.G. Terrill's E. line; thence with said H.G. Terrill's E. line N.20° 53' W. 2637.0 feet to a post at C. & A. Fish S.E. corner and Carl Lease S.W. corner; thence with said Carl Lease South line N.79° 35' E. 741.0 feet to a post in Clay Lease West line; thence with said Clay Lease West line S.10° 52' E. 1005.0 feet to a stake at Clay Lease S.W. corner; thence with Clay Lease South line N.79° 30' E. 1183.7 feet to a concrete post marked Rushcreek-Bokescreek and said post being the line between the two Townships; thence continuing with Clay Lease South line N.79° 30' E. 973.5 feet to the place of beginning, said tract containing 74.07 acres in Rushcreek Township and 22.60 acres

Titus 25 acre tract and said stone being the beginning point of this survey; thence with Titus E. line N. 7 1/2° W. 1318 feet to said Titus N.E. corner; thence N. 80° E. 1514 feet to the S.E. corner of a 25 acre tract now owned by Terrell; thence with East line of said 25 acre tract and the East line of R.
