Beginning at a railroad spike in the centerline of County Highway 48 at the northwest corner of Harvey Terrill's 27.66 acre tract as described in D.B. Vol. 399 Page 661 in the east line of the old T. & O. C. railroad (presently Conrail).

THENCE with the centerline of C.H. 48 N. 80° 00 E. (this bearing is taken from D.B. Vol. 399 Page 661 and all other bearings are from angles and distances measured in this field survey) 995.90 feet to a railroad spike at the northwest corner of Wesley Kavanagh's 69.75 acre tract.

THENCE with said Kavanagh's west line S. 10° 01' 30" E. 305.00 feet to a 6 inch wood corner post.

THENCE S. 83° 10' 30" W. 1001.71 feet to a 0.625 inch iron bar in the east line of said Conrail.

THENCE with said east line N. 9° 02' 06" W. 249.52 feet to the place of beginning.

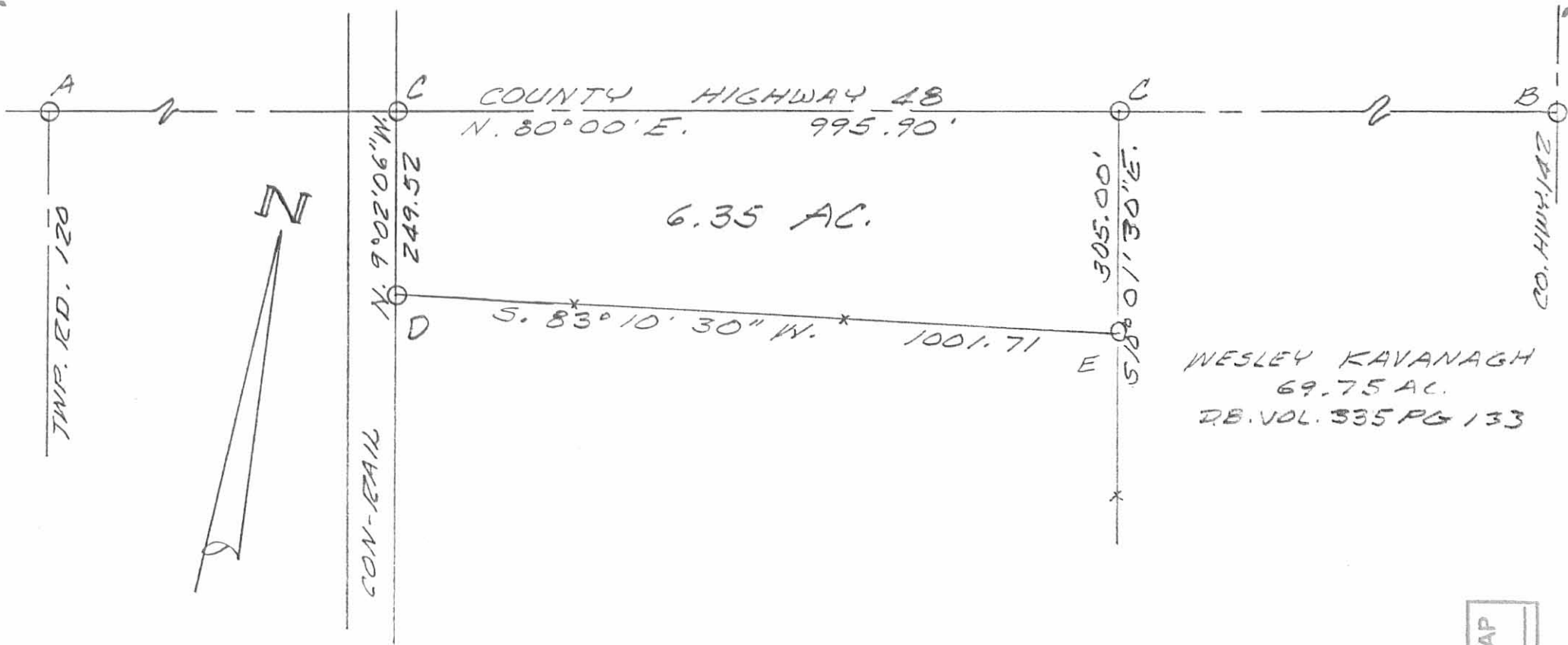

Thence with said Kavanaugh's west line S. 10° 01' 30" E. 305.00 feet to a 6 inch wood corner post found at the northeast corner of Dean Teriill's 56.310 acre tract as described in O. R. Vol. 121 Page 563.

Thence with said Terrill's north line S. 83° 10' 30" W. 50.07 feet to a 5/8 inch iron bar set.

Thence N. 10° 01' 30" W. 302.23 feet to a cap and nail set in the centerline of said C. H. 48.

Thence with said centerline N. 80° 00' 00" E. 50.00 feet to the place of beginning.

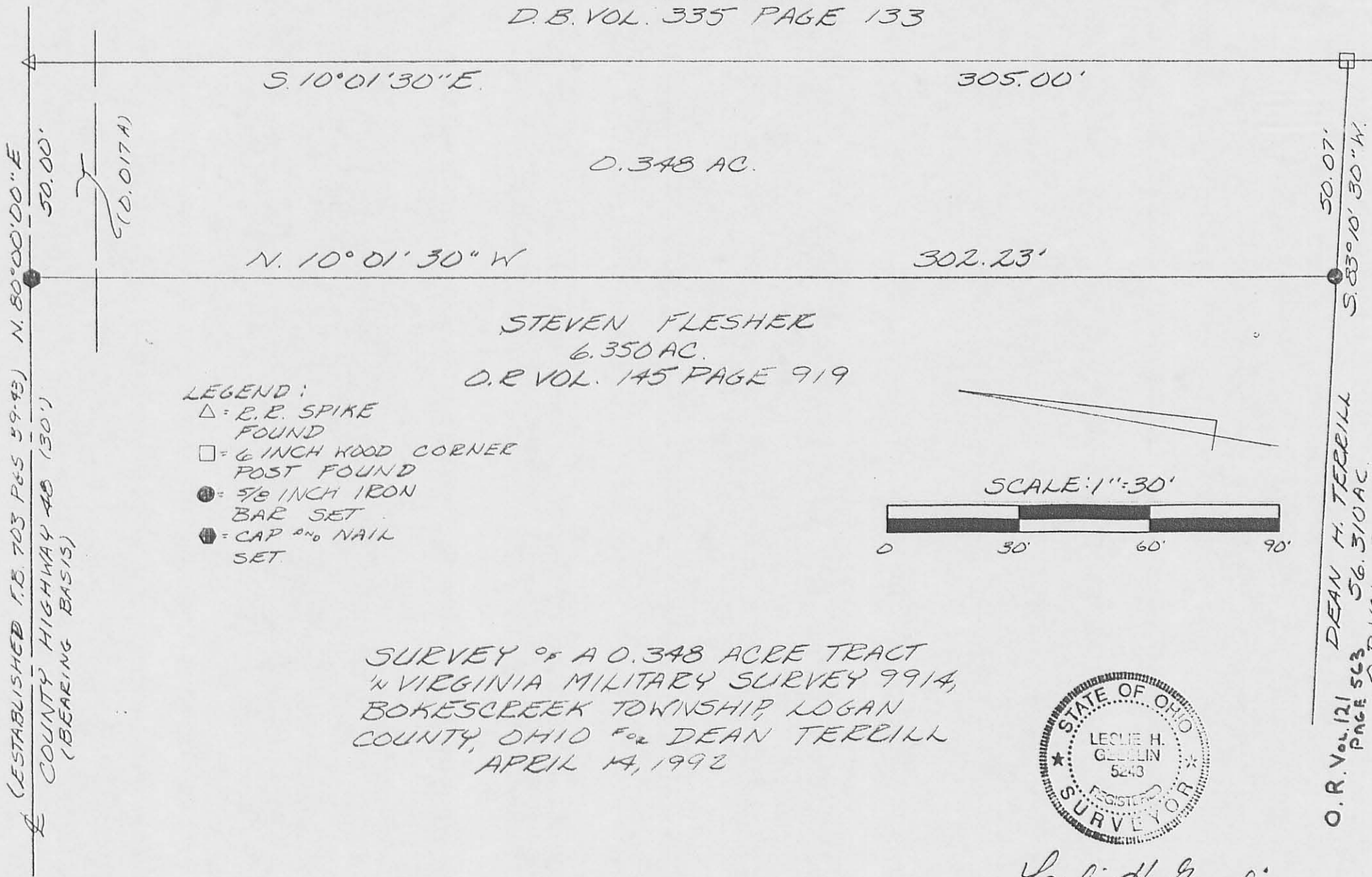

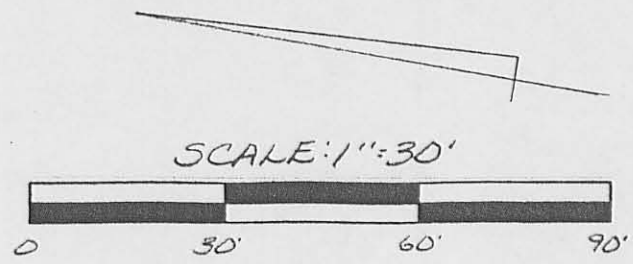
