Beginning at the intersection of the west line of said Section 12 with the center line of County Road 13.

Thence with the center of County Road 13 S 85° - 31'E 1214.0 feet.

The following four courses are in the Bokengehalas Creek.

Thence S 23° - 53'E 490.0 feet.

Thence S 60° - 39'E 429.5 feet.

Thence S 70° - 44'E 260.0 feet.

Thence S 50° - 02'E 252.0 feet to a point in the west line of a 8.43 acre tract.

Thence with said west line of said 8.43 acre tract S 4° - 05'W 43.0 feet to a iron.

Thence with the south line of said 8.43 acre tract S 52° - 40'E 442.0 feet to a iron.

Thence S 3° - 52'W 393.0 feet to a iron. This line is 30.0 feet west of and parallel to the west side of a 128.97 acre tract.

Thence N 85° - 39'W 1131.0 feet to a iron.

Thence S 3° - 27'W 425.0 feet to a iron.

Thence S 23° - 53'E 259.3 feet to a iron.

Thence N 85° - 47'W 322.0 feet to a iron.

Thence N 9° - 12'W 82.9 feet to a iron.

Thence N 68° - 56'W 346.0 feet to a iron.

Thence N 5° - 51'E 226.3 feet to a iron.

Thence N 50° - 38'W 261.6 feet to a iron.

Thence with the west line of Section 12 N 4° - 15'E 1611.0 feet to the place of beginning.

Thence with the center of County Road 13 S $85^{\circ} - 31'E$ 1073.0 feet to a iron at the northwest corner of a 8.43 acre tract.

Thence with the west line of said 8.43 acre tract S $4^{\circ} - 05'W$ 824.5 feet to a point in the Bokengehalas Creek.

The following four courses are in the Bokengehalas Creek.

Thence N $50^{\circ} - 02'W$ 252.0 feet.

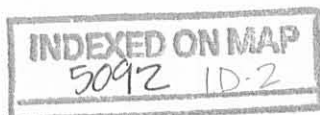
Thence N $70^{\circ} - 44'W$ 260.0 feet.

Thence N $60^{\circ} - 39'W$ 429.5 feet.

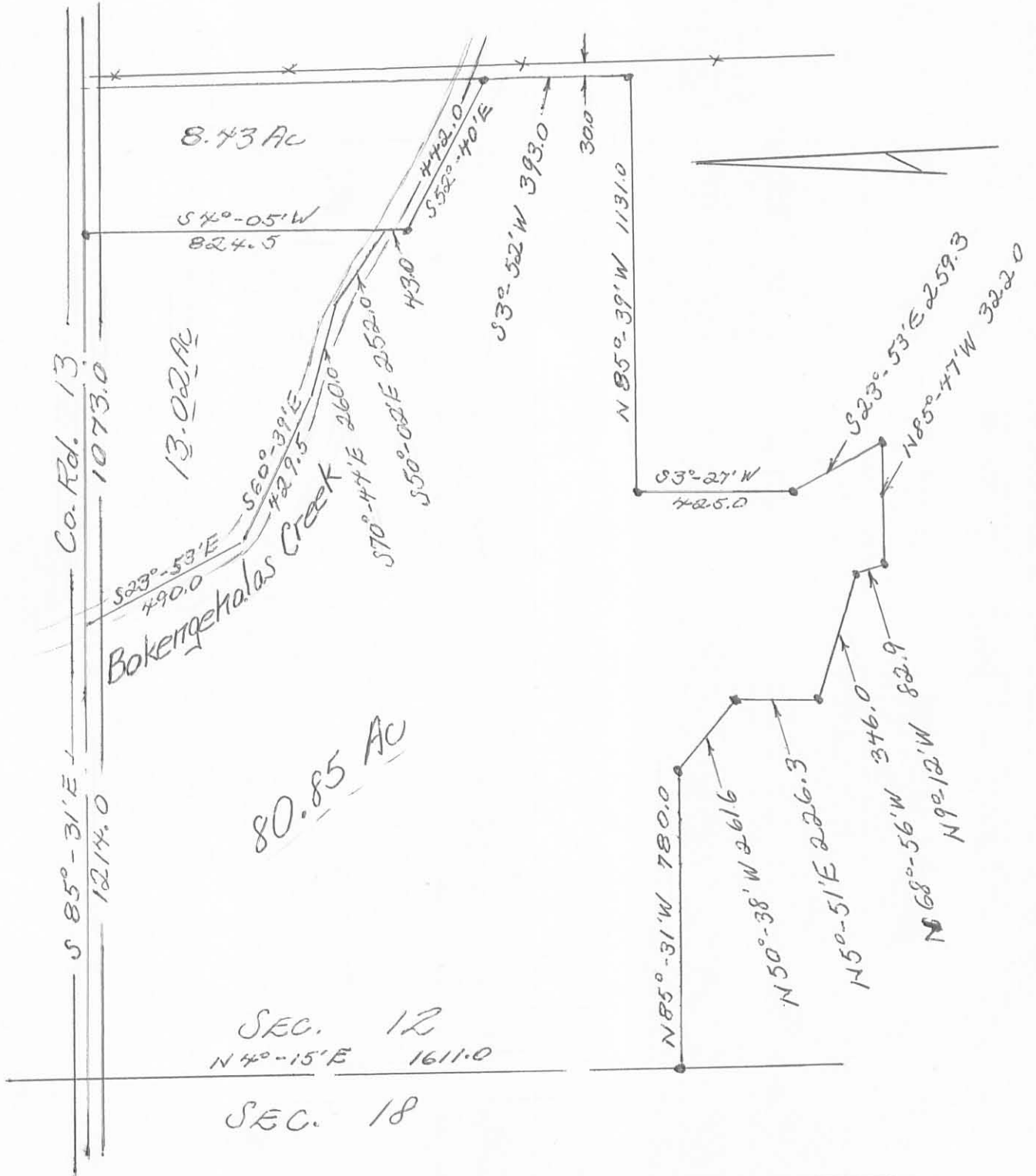
Thence N $23^{\circ} - 53'W$ 490.0 feet to the place of beginning.
