HARMAN SURVEY

September 10, 1997

The following described real estate situated in the State of Ohio, County of Logan, Township of Jefferson, being part of Virginia Military Survey 3442 and more particularly described as follows:

Beginning at a R. R. spike found at the intersection of the centerlines of State Route 47 and Township Road 230.

Thence with the centerline of said S. R. 47 and a tangent thereof N. 50° 03' 26" E. 680.04 feet to a 5/8 inch iron bar found at the point of intersection of a 287.9 foot radius curve to the right, said curve having a central angle of 32° 11' 34".

Thence with a tangent of the centerline of said S. R. 47 N. 82° 15' 00" E. 29.45 feet to a magnetic nail set.

Thence S. 0° 13' 21" E. 423.22 feet to a 5/8 inch iron bar set in the north line of Wilson L. Wilgus, et ux's 20.96 acre tract as described in D. B. Vol. 340 Page 731, passing a 5/8 inch iron bar set at 36.78 feet.

Thence with said Wilgus' north line S. 85° 18' 57" W. 540.90 feet to a 1 inch iron pipe found in the centerline of Township Road 230, passing a 5/8 inch iron bar set at 523.18 feet.

Thence with the centerline of said T. R. 230 N. 26° 02' 59" W. 29.85 feet to the place of beginning.

Containing 2.978 acres more or less of which 0.497 acre is in the right of way of State Route 47 and 0.002 acre is in the right of way of Township Road 230.

The above described 2.978 acre tract being the west part of Carolyn L. Harman's 10.42 acre tract as described in D. B. Vol. 392 Page 670.

Bearings are based on an assumed bearing (N. 50° 03' 26" E.) for the centerline of State Route 47 in this field survey by Leslie H. Geeslin, Reg. Surveyor 5248 on September 10, 1997.

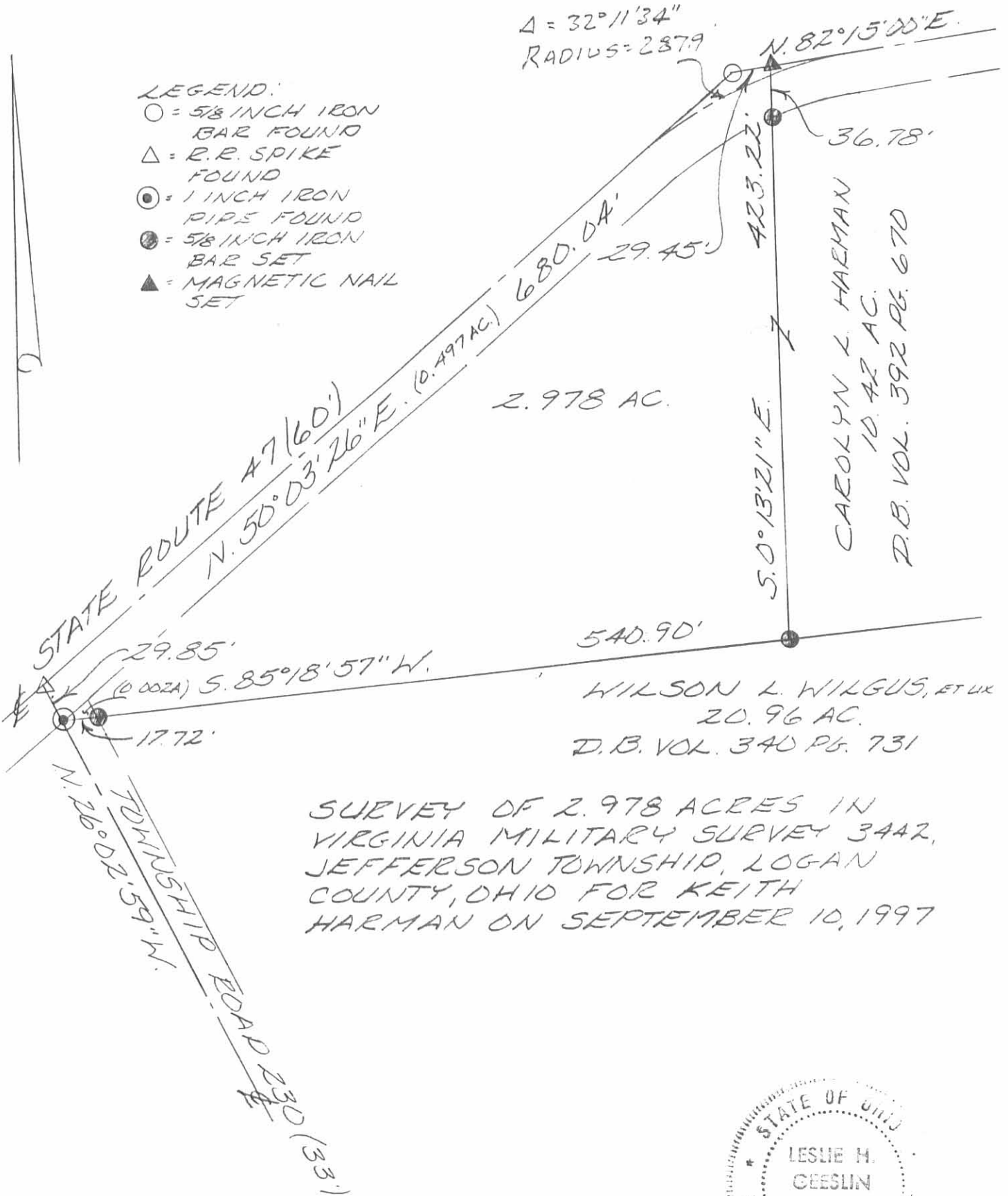

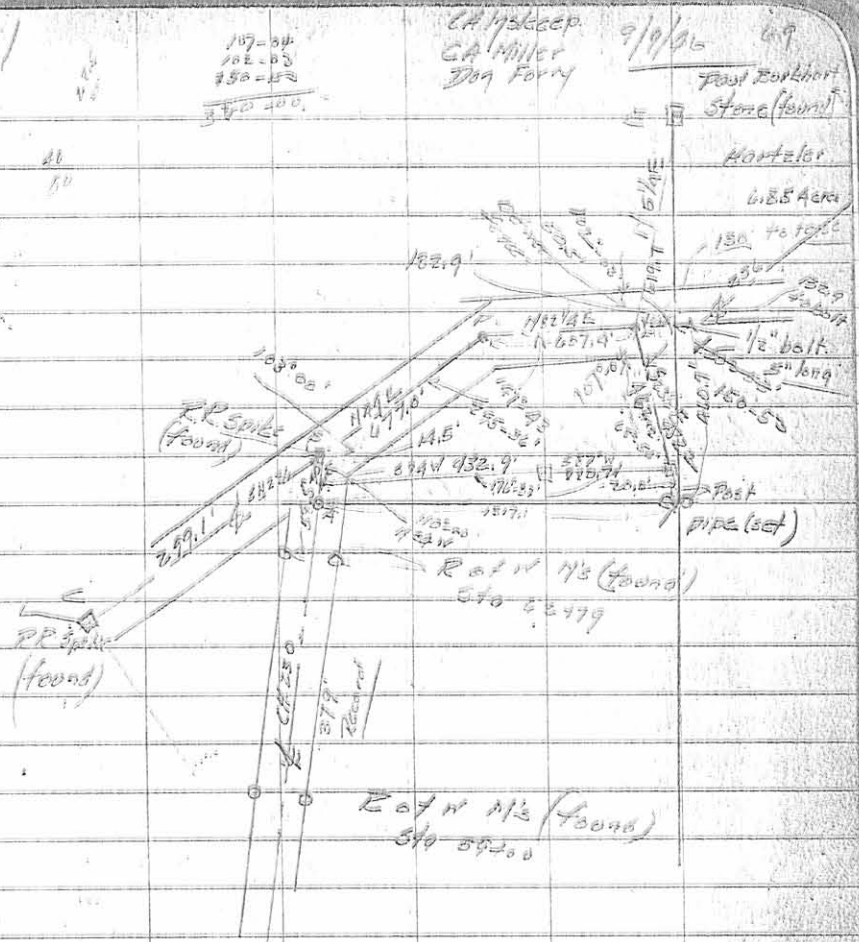

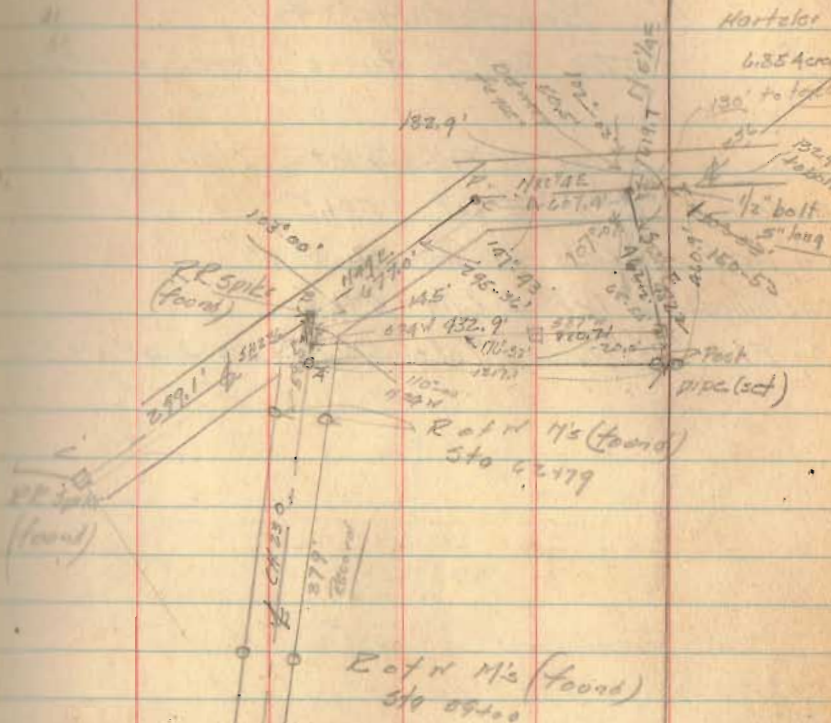
