Thence with the south right of way line of the new location of U.S. Route Number 33 N. 48 - 43 W. 312.50 feet to a concrete right of way marker known as station 990 plus 00 as shown on Logan County Engineer's Plans L - 40

Thence again with the south ~~line~~ right of way line of the new location of U.S. Route Number 33 N. 52 - 18 W. 488.60 feet to an iron.

Thence S. 5 - 17 W. 102.00 feet to an iron.

Thence N. 85 - 09 W. 159.00 feet to an iron.

Thence S. 31 - 55 E. 143.00 feet to a post.

Thence S. 4 - 00 W. 880.00 feet to a post at the N.W. corner of Clarence F. ~~Myers~~ Myers 109.04 acre tract.

Thence with the north side of said Myers 109.04 acre tract S. 86 - 30 E. 691.00 feet to the place of beginning.

The above described contains 14.67 acres. 0.22 of one acre being out of a 11.88 acre tract and 14.45 acres being out of a 59.83 acre tract.

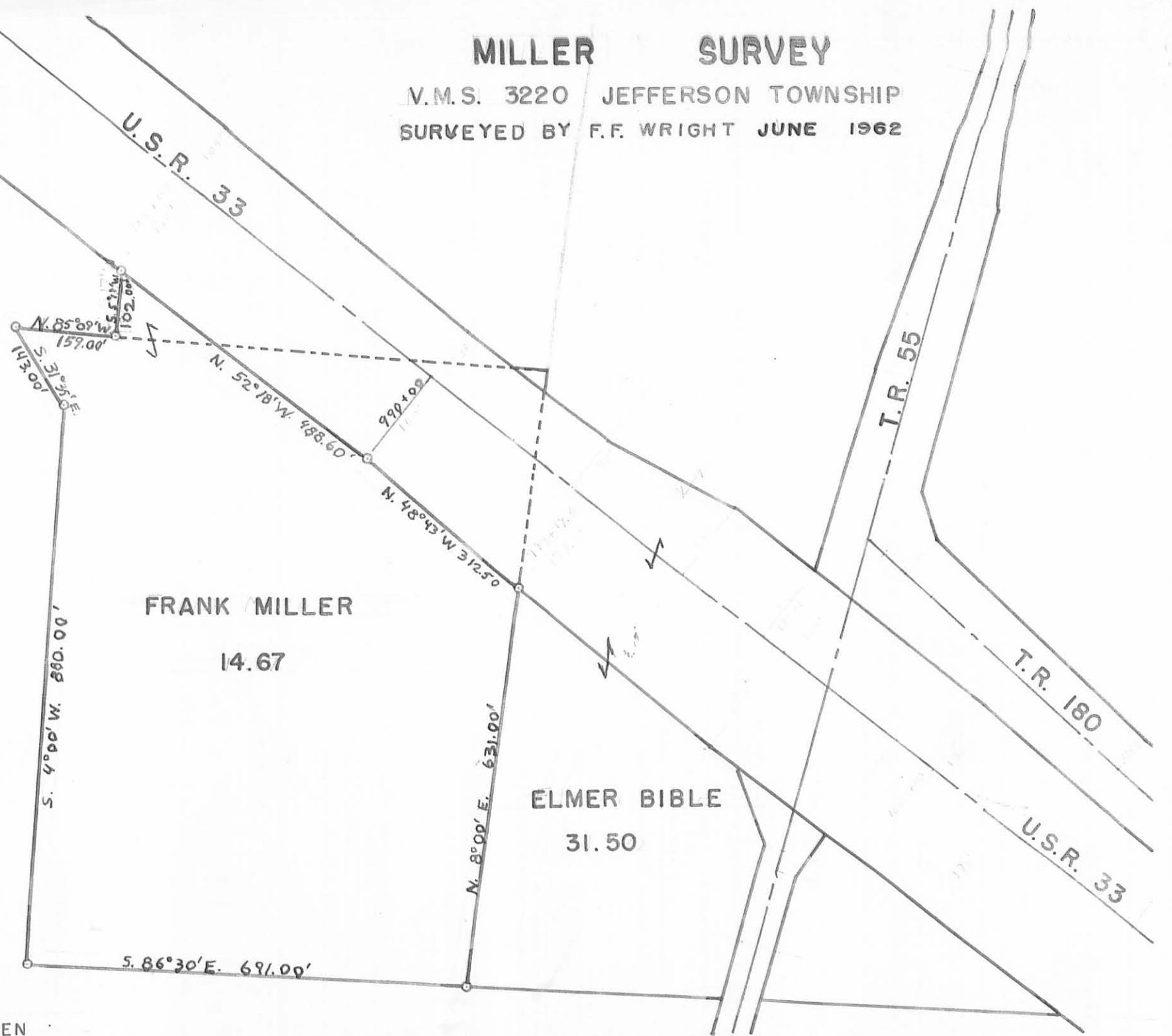
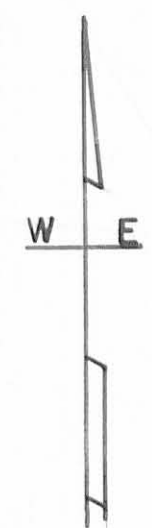

Thence with the south side of said Bible 31.50 acre tract N. 84 - 59 W. 403.70 feet to a wood post at the S.W. corner of said Bible 31.50 acre tract and also being the S.E. corner of Frank L. Miller's 59.83 acre tract.

Thence S. 5 - 01 W. 35.00 feet to an iron.
