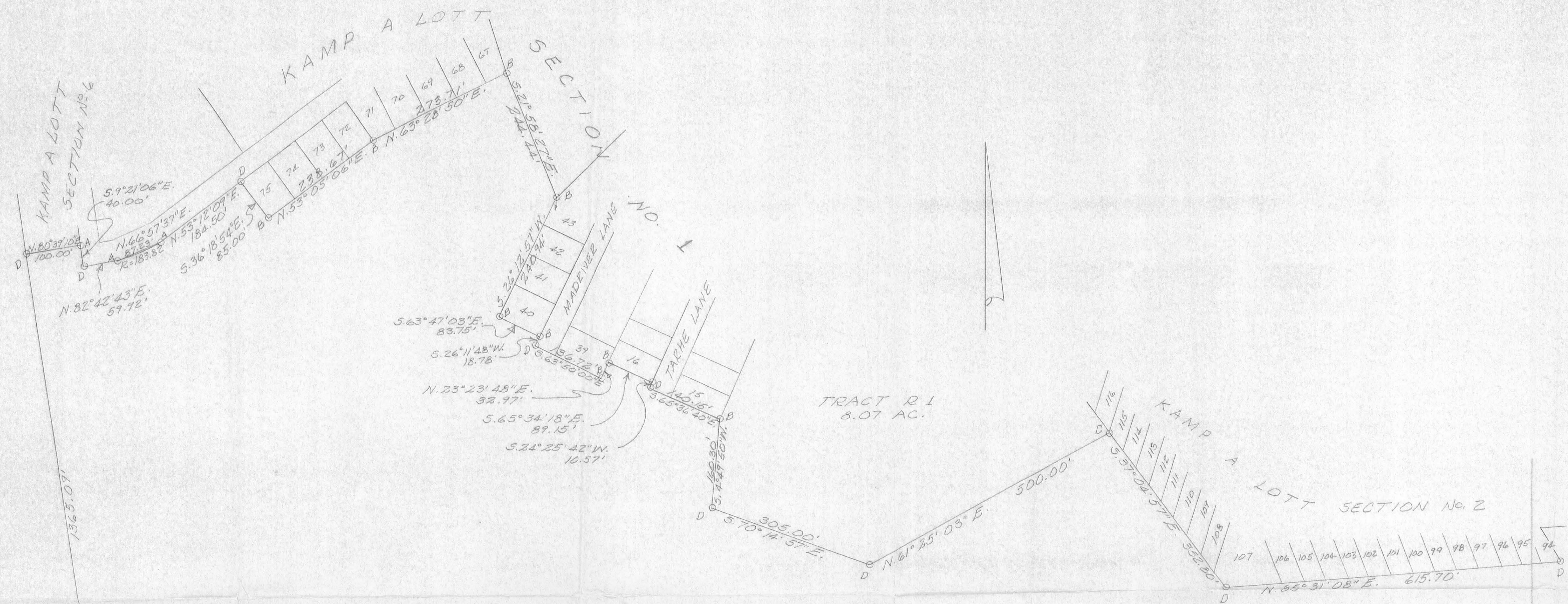
SURVEY OF 116.651 ACRE TRACT
