

The following described real estate situated in the Township of Lake, County of Logan, State of Ohio and being a part of Virginia Military Survey No. 5045 and being more particularly described as follows:

Beginning at an iron bar, Northeast corner of Lot No. 18, Heidi Road Allotment and in the south line of Dorothy Lane as recorded in Plat Book 6-F, Page 34, Logan County Recorders Office;

Thence with the east line of Lot No. 18, S. $3^{\circ} 47'$ E. 91.90 feet to an iron bar, southeast corner of Lot No. 18 and northeast corner of Lot No. 19;

Thence with the east lines of Lots 19, 20, 21 & 22, S. $13^{\circ} 15' 50''$ E. 496.03 feet to an iron bar in the north line of Ralph E. Fitzpatrick's present 6.66 Acre tract and southeast corner of Lot No. 22;

Thence with Fitzpatrick's north line, S. $86^{\circ} 11' 50''$ E. 524.2 feet to a six inch wood post in the East line of V.M.S. No. 5045 and the West line of V.M.S. No. 4498;

Thence with said V.M.S. line, N. $4^{\circ} 40'$ E. 465.2 feet to an iron bar, southeast corner to David Costin's present 1.45 Acre tract;

Thence with Costin's south and west lines the following four courses and distances; S. $71^{\circ} 57' 40''$ W. 154.60 feet to an iron bar, S. $81^{\circ} 57' 40''$ W. 182.90 feet to an iron bar, N. $55^{\circ} 00'$ W. 257.00 feet to an iron bar (southwest corner to Costin's present 0.65 Acre tract) and N. $0^{\circ} 30'$ E. 140.0 feet to an iron bar in the south line of Dorothy Lane and northwest corner to Costin's present 0.65 Acre tract;

Thence with the south line of Dorothy Lane the following three courses and distances to the beginning, N. $89^{\circ} 30'$ W. 8.0 feet to an iron bar (the P. C. of a curve to the left having a central angle of $52^{\circ} 27' 20''$ and a radius of 60.19 feet) an arc distance of 54.87 feet to an iron bar, (said iron bar being the P. C. C. of a curve to the right having a central angle of $52^{\circ} 22'$ and a radius of 110.42 feet) an arc distance of 100.93 feet, containing 6.50 Acres, more or less:
