Thence with the right-of-way of said C. H. 9 N.  $35^{\circ}$  10' E. 88.40 feet to a 0.625 inch iron bar set.

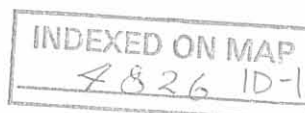
Thence with said R/W N.  $54^{\circ}$  50' W. 25.00 feet to a 0.625 inch iron bar set.

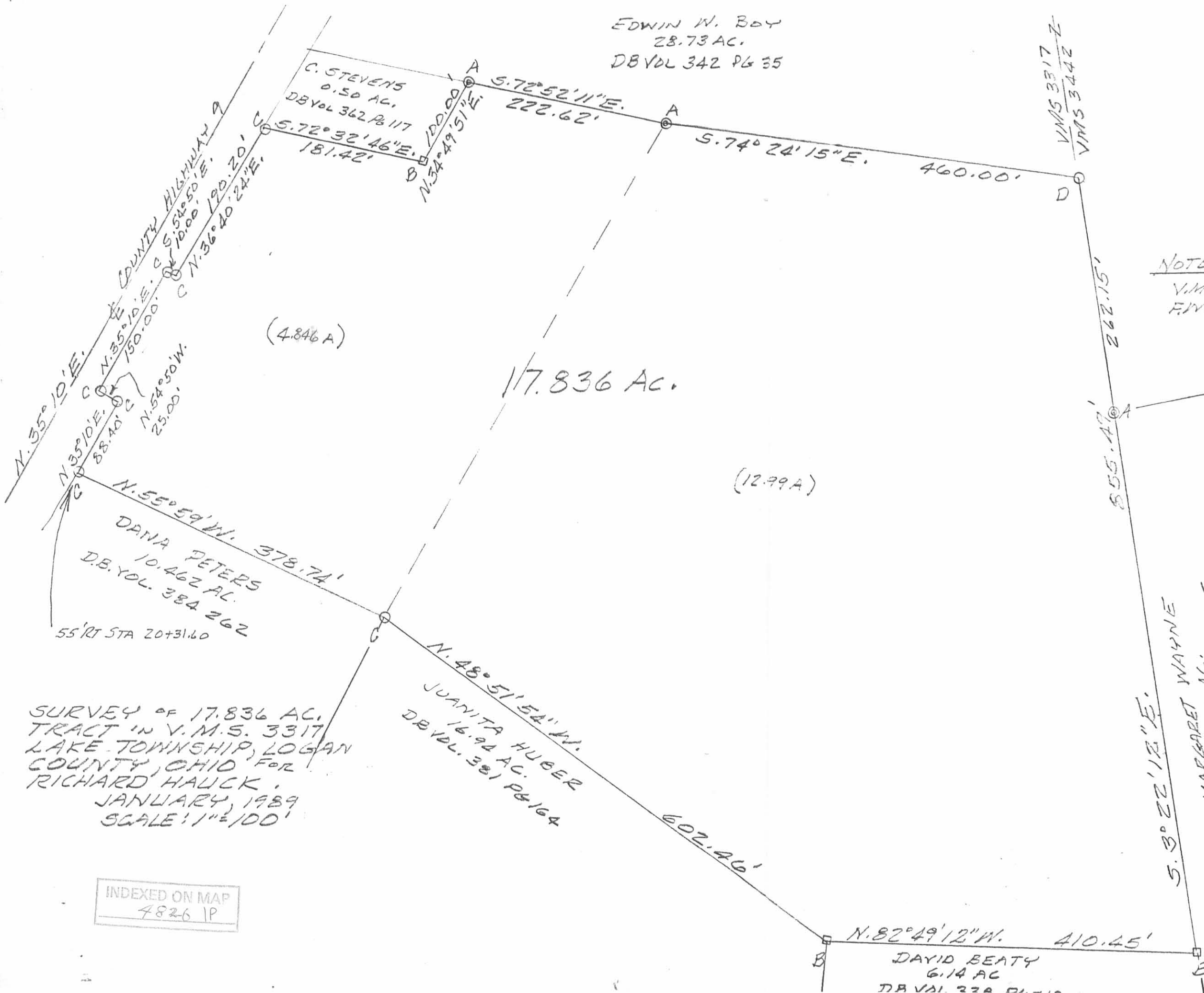
