Lying in the west half of the northwest quarter of Section 29, Town 5, Range 13, Liberty Township, Logan County, Ohio.

Being out of the Jack Claxton 57.43 acre tract as deeded and described on Volume 287, Page 443 of the Logan County Records of Deeds and being more particularly described as follows:

Beginning at a tacked hub found at the northwest corner of the Cedar Heights Allotment (Plat Cabinet A, Slide 503) on the center-line of Township Road 30 and the north line of Section 29.

THENCE, with the west line of said Cedar Heights Allotment, S 5°-04'-09" W, a distance of 213.28 feet to a 5/8 inch iron rod set, passing through a 5/8 inch iron rod set at 20.00 feet.

THENCE, N 83°-45'-40" W, a distance of 246.61 feet to a 5/8 inch iron rod set at the southeast corner of the Gary D. McKee 0.918 acre tract (0.R. 11, Pg. 605).

THENCE, with the east line of said 0.918 acre tract, N 4°-47'-00" E, a distance of 213.30 feet to an iron spike found on the center-line of said Township Road 30, passing a 5/8 inch iron rod found at 193.30 feet.

THENCE, with the center-line of said Township Road and the north line of Section 29, S 83°-45'-40" E, a distance of 247.67 to the point of beginning.

Containing 1.210 acres of which 0.114 acre is within the road right-of-way.

The basis for bearings is based upon the center-line of Township Road 30 being S 83°-45'-40" E, and all other bearings are from angles and distances measured in a field survey by Lee Surveying and Mapping Company on August 18, 1992.







Woodard by Deed recorded in Official Record 467, Page 476 of the Logan County Records;

thence with the West line of said Woodard's 0.40 acre tract S-5°02'39"-W, 100.00' (feet) to a 5/8" diameter iron bar with Lee cap found at grade at the Northwest corner of a 5.23 acre tract conveyed to Douglas E. Perin by Deed recorded in Official Record 255, Page 173 of the Logan County Records, also being at the Northeast corner of a 5.000 acre tract also conveyed to Douglas E. Perin by Deed recorded in Official Record 261, Page 95 of the Logan County Records;

thence with the North line of said Perin's 5.000 acre tract, N-84°57'24"-W, 230.16' (feet) to a 5/8" diameter iron bar found at grade at the Northwest corner of said Perin's 5.000 acre tract;

thence with the West line of said Perin's 5.000 acre tract, S-4°57'40"-W, 71.77' (feet) to an iron bar set on the South line of a 16.05 acre tract conveyed to Jack Claxton by Deed recorded in Deed Volume 287, Page 442, Tract 1, of the Logan County Deed records, of which the herein described parcel is the remainder of, also being on the North line of a 57.43 acre tract also conveyed to Jack Claxton by Deed recorded in Deed Volume 287, Page 442, Tract 2, of the Logan County Deed Records;

thence with the South line of said Claxton's 16.05 acre tract, also being the North line of said Claxton's 57.43 acre tract, N-83°45'40"-W, 634.90' (feet) to an iron bar set replacing a 5/8" diameter iron bar found, disturbed, at the Southeast corner of a 2.13 acre tract conveyed to David E. Wallace, Jr. by Deed recorded in Official Record 245, Page 579 of the Logan County Records;

thence with the East line of said Wallace's 2.13 acre tract and with the East line of a 2.82 acre tract conveyed to Gary L. Marchal by Deed recorded in Official Record 536, Page 863 of the Logan County Records, and with the East line of a 4.00 acre tract conveyed to Douglas M. Johnson by Deed recorded in Deed Volume 378, Page 667 of the Logan County Deed Records, N-4°39'26"-E, 561.60' (feet) to a 5/8" diameter iron bar found at grade at the Southwest corner of a 1.032 acre tract conveyed to John F. Marmon by Deed recorded in Official Record 18, Page 663 of the Logan County Records, passing for reference a 5/8" diameter iron bar found projecting 0.4' (foot) above grade at the Northeast corner of aforementioned Wallace's 2.13 acre tract at 191.07' (feet);

thence with the South line of said Marmon's 1.032 acre tract, S-83°45'40"-E, 187.64' (feet) to an iron bar set at the Southeast corner thereof;

thence with the East line of said Marmon's 1.032 acre tract, N-4°39'26"-E, 239.80' (feet) to a railroad spike found 0.1' (foot) below grade on the centerline of Township Road 30 (40' right-of-way) at the Northeast corner of said Marmon's 1.032 acre tract, passing for reference a 5/8" diameter iron bar found 0.1' (foot) below grade on the right-of-way line of Township Road 30 at 219.79' (feet);

thence with the centerline of Township Road 30 S-83°45'40"-E, 60.33' (feet) to a railroad spike found 0.1' (foot) below grade at the Northwest corner of a 0.918 acre tract conveyed to Joel A. Wilson by Deed recorded in Official Record 495, Page 178 of the Logan County Records;

Pulda by Deed recorded in Official Record 423, Page 44 of the Logan County Records, S-83°45'40"-E, 621.59' (feet) to a point at the Southwest corner of said Pulda's 1.210 acre tract and on the West line of aforementioned Cedar Heights Allotment, from which a 5/8" diameter iron bar with Lee cap found at grade bears S-60°30'24"-E, 0.34' (feet), passing for reference a 5/8" diameter iron bar with Lee cap found at grade at the Southwest corner of said Pulda's 1.210 acre tract at 375.20' (feet);

thence with the West line of said Cedar Heights Allotment S-5°02'39"-W, 411.42' (feet) to the place of beginning.

Containing 11.489 acres, 0.028 acre of which is within the road right-of-way, but being subject to the rights of all legal highways and all easements of record.




