Beginning at a cap and nail set in the centerline of County Highway 130 at the southeast corner of Randall Middaugh's 17.27 acre tract as described in O. R. Vol. 22 Page 79.

Thence with said centerline S. 7° 20' 00" E. 174.80 feet to a cap and nail set.

Thence S. 81° 44' 41" W. 253.10 feet to a 5/8 inch iron bar set, passing 5/8 inch iron bars set at 30.00 feet and 179.76 feet.

Thence N. 7° 20' 00" W. 182.92 feet to a 5/8 inch iron bar set in the south line of said Middaugh's 17.27 acre tract.

Thence with said Middaugh's south line N. 83° 35' 03" E. 253.10 feet to the place of beginning, passing a 5/8 inch iron bar ~~hand~~ at 223.10 feet.

Containing 1.039 acres more or less, of which 0.120 acre is in the right of way of C. H. 130.

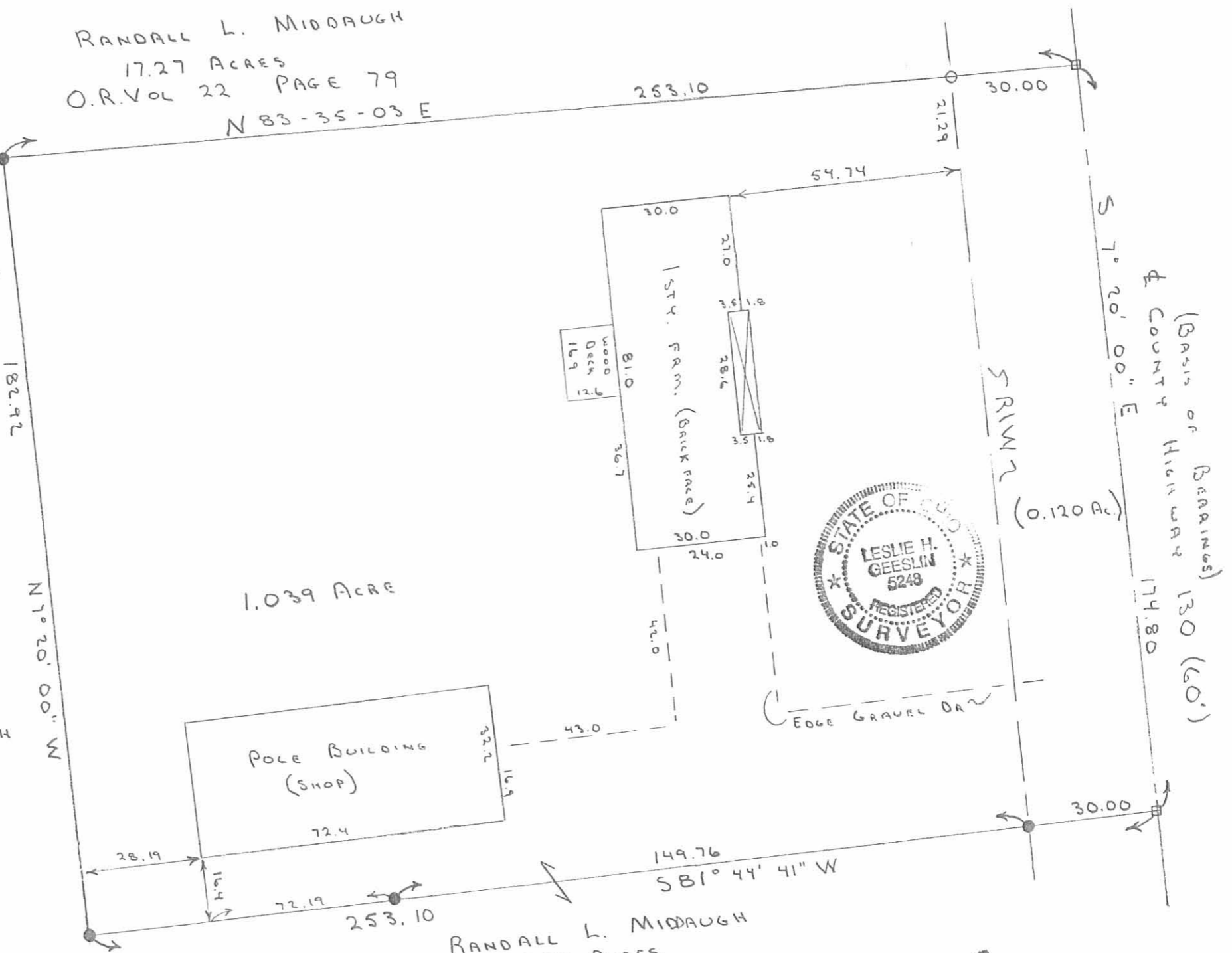
