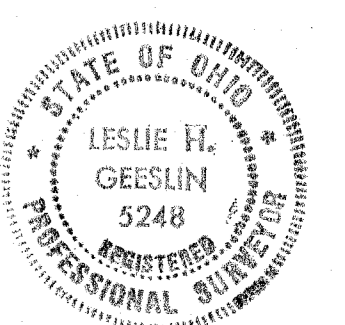


SURVEY OF 106.614 ACRE TRACT
