Robinson Survey (Miami Township)

The following described land in Section 30, Town 3, Range 13 and Section 29, Town 3, Range 13 of between the Miami River's survey and being in Miami Township, Logan County, Ohio.

Beginning at S.E. corner of Section 30, T 3, R 13, and being sta. 46+82 of new right-of-way of S.H. #27 as shown in Plan W-5 on file in Logan County Engineer's Office, thence with East side of Section 30, N-6°-19' W. 615.0 feet to a concrete R/W post, thence N. 7°-39' W. 500.0 feet to a stake in N. line of section 30 and at the South side of Great Miami River also being the N.W. corner of tract of land in name of T.B. Miller the last described line passing the North corporation line of Quincy at 319.0 feet. Thence with the North and East line of said section 30 and also being the South and West side of Great Miami River; the following Twelve causes and distances.

(under High Bridge) S. 80°-11' W. 300.0 feet to stake, N. 84°-54' W. 455.0 feet to mark on a sycamore root, N. 85°-04' W. 402.0 feet to a mark on a sycamore root, N. 88°-49' W. 486 feet to a stake at N.H. corner of Mimmie Leaches 13.97 acre tract, thence with East side of said Leach tract S. 50-431 E. 988.0 feet to a concrete post the last described line passing the East side of a large Hackberry At. 70.0 Ft, Thence continuing with East sides of said tract S. 5°-31' E. 1070.0 feet to concrete post, S. 4°-50' E. 930.0 feet to a stake at S.E. corner of said 13.97 acre tract and being in South line of section 30, thence with the south line of section 30 and the North line of Minnie Leach 26.03 acre tract, N. 810-0' E. 659.0 feet to a point in West line of Quincy corporation, thence with S. line of section 30 N. 81°-0' H. 166.0 feet to a point N.E. corner of Minnie Leachs 5.0 acre tract and N.W. corner of Robinson 17.64 acre tract; thence with East side of said 5.0 acre tract S. 5°-43' . 1279.0 feet to a post in center of County Road No. 70, thence with center of road No. 70 N. 750-29 E. 641.0 feet to a past at S.E. corner of Robinson 17.64 acre tract, thence N. 50tract and in South line of section 30, thence with the south line of section 30, N. 80°-531 E. 1220.0 feet to place of beginning the last described line passing west right-of-way fence of D.T. & I. RR at 263.0 feet and the East right-of-way fence D.T. & I. RR at 337.0 feet. The above tract having been surveyed Sept 1936 as shown in Logan County Engineers Book 597, Pages 68, to 72. Excepting from the above 0.26 acres out of S.E. corner of Sec. 30, conveyed by Robinson to State of Ohio as recorded in Logan County Recorders Records Vol. 153, Page 484 as follows.

Beginning at a point in the line between Section 30 and 29, said line being the Worth line of a public alley passing through sta. 46 plus 82 in the center line of survey made by the Department of Highways, said point being in the contuination of the west line of Carlisle St. and 30 feet west of the line between sections 30 and 24; thence N. 50-33' E. 333 feet, more or less, to a point 105 feet radial measure west of said center line of survey; thence north easterly with a curve to the right, same having a radius of 1823.87feet, a distance of 11C feet, more or less, to a point in the property line between the grantor and A.P. Chambers which is also the aforementioned line between sections 30 and 24, said point being 105 feet radial measure from said center line of survey; thence along said property and section line S. 50-33' W. 429 feet, more or less, to a point in the aforementioned line between section 30 and 29; thence west along said section line 30 feet to the place of beginning and containing 0.260 acres more or less, as shown by plans on file in the office of the Department of Highways, Columbus, Ohio, Also excepting 4.12 acres of land out of Sec. 30 conveyed by Stiles to R.R. Logan County Recorders Records Vol. 81, Page 462 as follows.

Beginning at a point in the center line of the located road of the Ohio Southern R.R. marked Station 1698+05, thence west along the boundry line between the said W. M. Stiles and Jonathan Cost to a point 33 feet from the center line of said O.S. R.R. at right angles thereto, thence parallel to said center line and 33 feet therefrom to the Great Miami River, thence up said river and crossing the center line of said railway at a point marked station 1725 + 25 to a point 33 feet from the said center line of railway at right angles thereto, thence parallel to said center line and 33 feet therefrom to a point on the boundary line between the

the said W.W. Stiles and Jonathan Cost; thence west along said boundry to the place of beginning, said tract containing 4.12 acres more or less, above described premises being part of section 30, Township 3, Range 13, being a strip of land 66 feet wide lying 33 feet on each side of the center line of main track of the said railroad companys extension.
