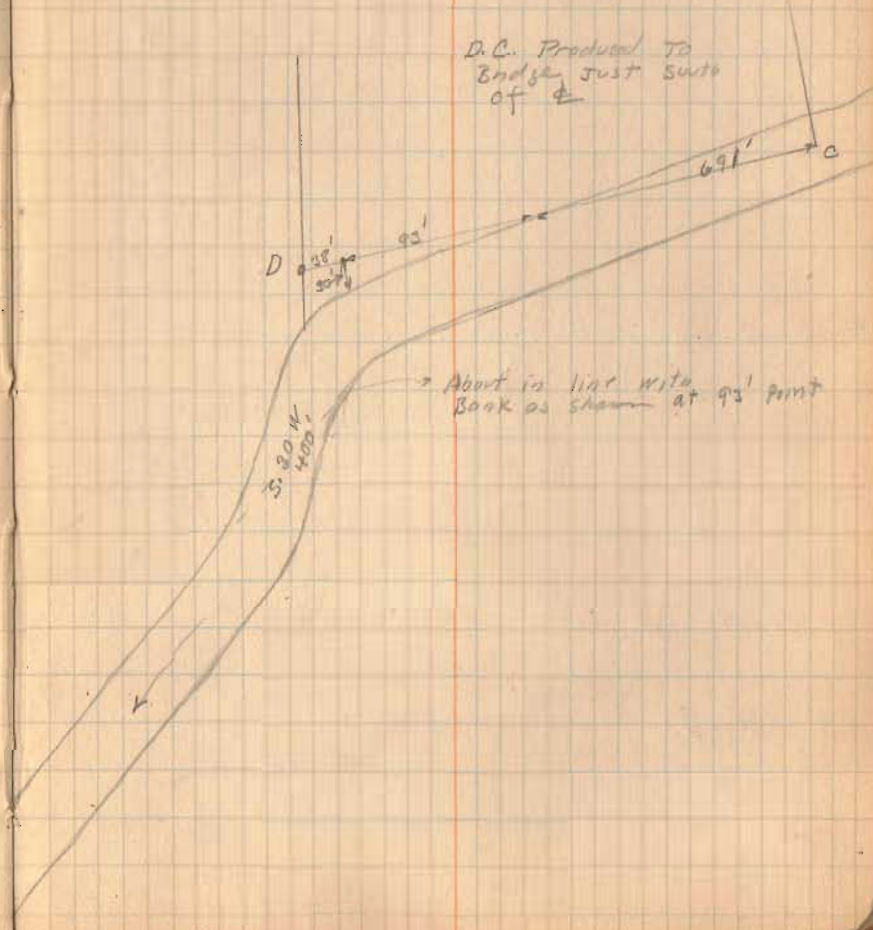

Beginning at the center of the North abutment of Mad River at the Ludlow Pike, thence S.E. with the center of said pike 36 feet to the center of Mad River (new channel dredged 1927) thence with the center of the creek S. 48 W. 2035 feet; S. 20 W. 115 feet; S. 35 W. 90 feet, thence N.E. with Smith's West line 128 feet to an old post, thence N. 46 E. 822 feet, thence N. 3° 30' W. 123.42 feet; thence N. 48° 30' E. 1250.70 feet to beginning, said tract containing 2.24 acres, more or less and being the same tract as marked "A" in Surveyor's Book 480 Page 55.
