The following described real estate situated in the State of Ohio, County of Logan, Township of Jefferson and being part of Virginia Military Survey 4477 and more particularly described as follows:

Commencing at a 5/8 inch iron bar found in the centerline of County Highway 29 at Station 61+34 as shown in Field Book 602 Page 27 said 5/8 inch iron bar found being in the north line of Thomas E. Fidago, et ux's 30.00 acre tract as described in O. R. Vol. 42 page 241.

Thence with the centerline of said C. H. 29 S. 59° 46' 00" E. 114.00 feet to a magnetic nail set for the place of beginning of this description.

Thence with the centerline of said C. H. 29 S. 59° 46' 00" E. 423.52 feet to a R. R. spike found at the northwest corner of Thomas E. Fidago, et ux's 18.808 acre tract as described in O. R. Vol. 308 Page 961.

Thence with the west line of said 18.808 acre tract S. 6° 23' 11" W. 674.72 feet to a 5/8 inch iron bar set, passing a 5/8 inch iron bar found at 32.80 feet.

Thence N. 59° 46' 00" W. 423.52 feet to a 5/8 inch iron bar set.

Thence N. 6° 23' 11" E. 674.72 feet to the place of beginning, passing a 5/8 inch iron bar set at 641.92 feet.

Containing 6.000 acres more or less of which 0.292 acre is in the right of way of County Highway 29.

The above described 6.000 acre tract being part of Thomas E. Fidago, et ux's 30.000 acre tract as described in O. R. Vol. 42 page 241.

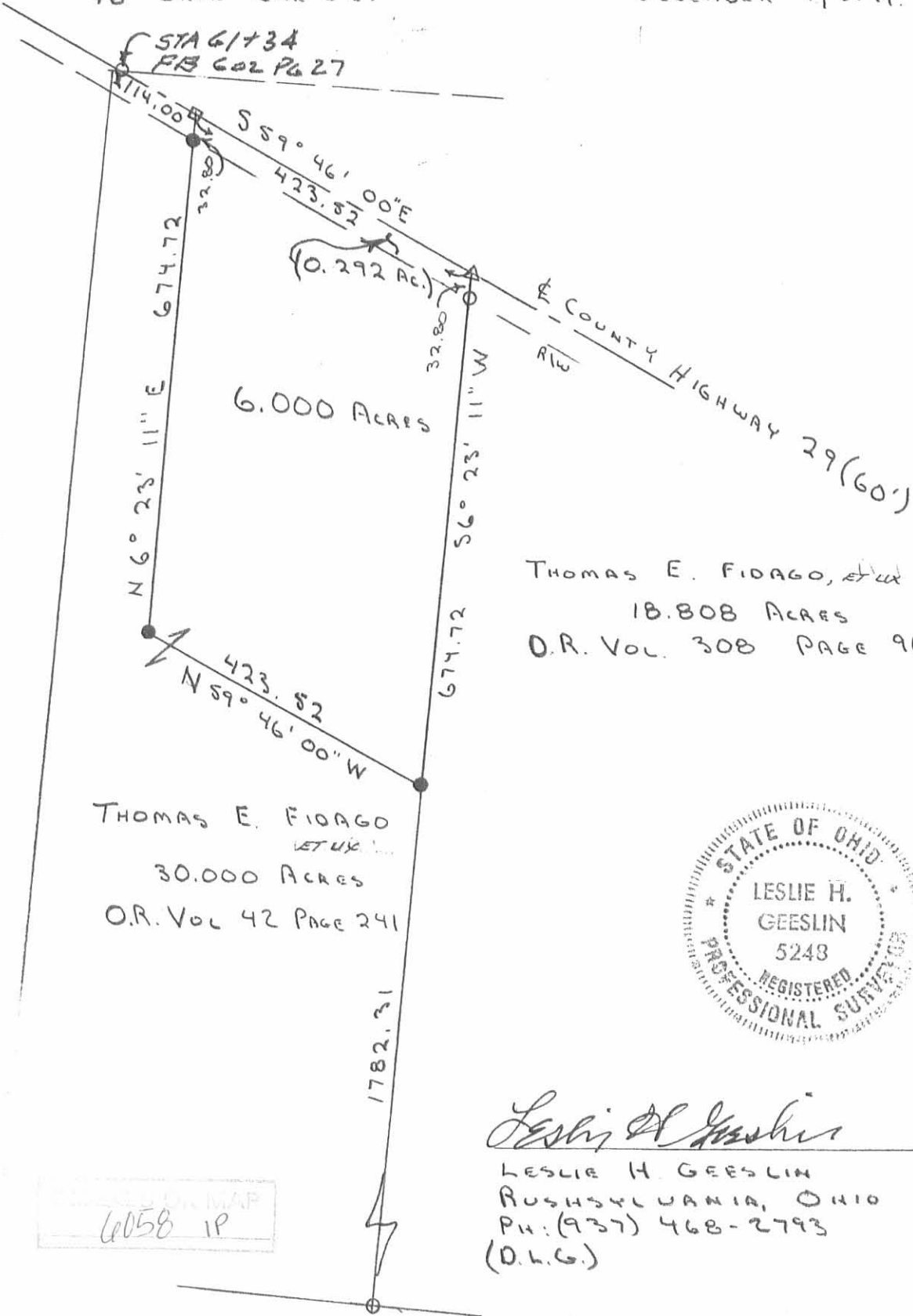

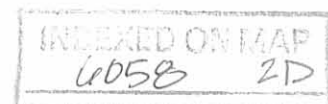

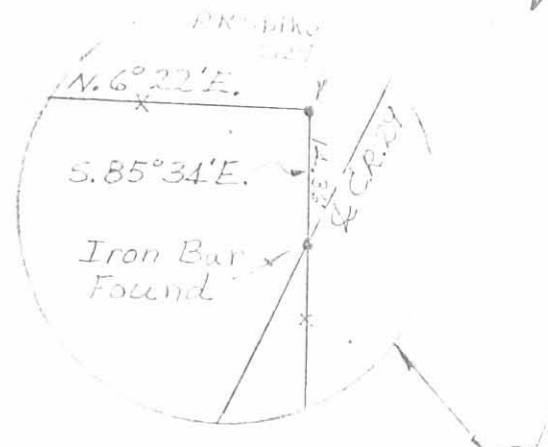

Burnside's 32.49 acre tract N.6°22'E. 1750.9 feet to a railroad spike; thence S.85°34'E. 14.36 feet to an iron bar in the center of County Road No. 29, said iron bar being Station 61+34 in Logan County Engineer's Field Book No. 602, page 27; thence with the centerline of said County Road No. 29 S.59°46'E. 537.3 feet to a railroad spike; thence S.6°22'W. 2457.2 feet to an iron bar in the north line of Gary E. Thompson's 5.67 acre tract, passing an iron bar at 32.8 feet and passing the said township line; thence with the north line of said Thompson's 5.67 acre tract N.82°06'W. 530.1 feet to a wood corner post at the northwest corner of said Thompson's 5.67 acre tract, said post also being in the east line of Don B. Kauffman's 83.85 acre tract; thence with the east line of said Kauffman's 83.85 acre tract N.7°54'E. 909.3 feet to the place of beginning.

Containing 30.00 acres, more or less, of which 10.87 acres are in Monroe Township and 19.13 acres are in Jefferson Township.
