Beginning at a R. R. Spike set in the centerline of C. H. No. 10 (Bristle Ridge Pike), said R. R. Spike being Station 85+49 as surveyed August 5, 1937 by F. F. Wright and recorded in Field Book No. 615 Page 12, said R. R. Spike also being the Northwest corner of Romona Dunaway's tract and Northeast corner to Darrell Jolliff's tract;

Thence with the line between Dunaway and Jolliff, S. 43° 49' W. 1758.9 feet to a wood corner post, southwest corner to Dunaway and in the northeast line of Ben N. Reames et al tract, passing the line between V.M.S. No. 5088 and V.M.S. No. 9198 at 370 feet, plus or minus;

Thence with the line between Jolliff and Reames, N. 32° 41' W. 196.0 feet to a Large wood corner post, most northerly corner to Reames;

Thence N. 43° 32' E. 602.0 feet to a R. R. Spike set in the center line of C. H. No. 10 and being Station 89+49.4 of said road survey, passing the line between V.M.S. No. 9198 and V.M.S. No. 5088 at 500 feet, plus or minus, and an iron bar at 570.7 feet;

Thence with the center line of C. H. No. 10, S. 73° 00' E. 349.4 feet to an iron bar, being Station 86+00 of said road survey;

Thence continuing with said center line, S. 73° 41' E. 51.0 feet to the place of beginning, containing 13.22 Acres, more or less. Of the above 13.22 acres, there is 11.28 acres in V. M.S. No. 9198 and 1.94 acres in V.M.S. No. 5088.

Thence S. $52^{\circ} 17'$ W. 489.4 feet to an iron bar;

Thence S. $16^{\circ} 02'$ W. 502.0 feet to a large wood corner post, most northerly corner to Ben N. Reames et al tract;
