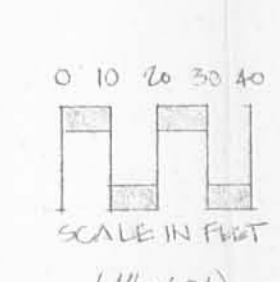


LOCATION MAP

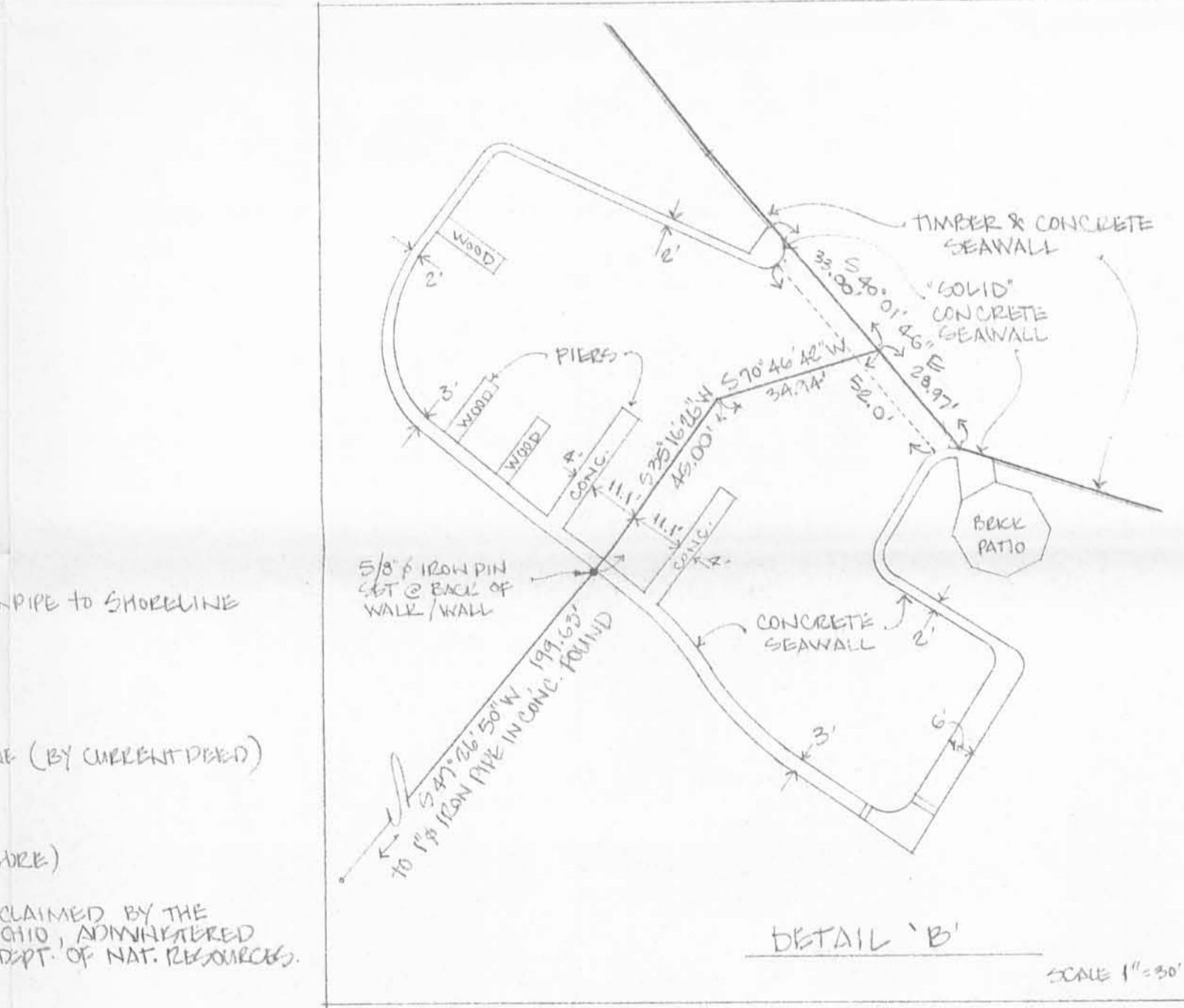
