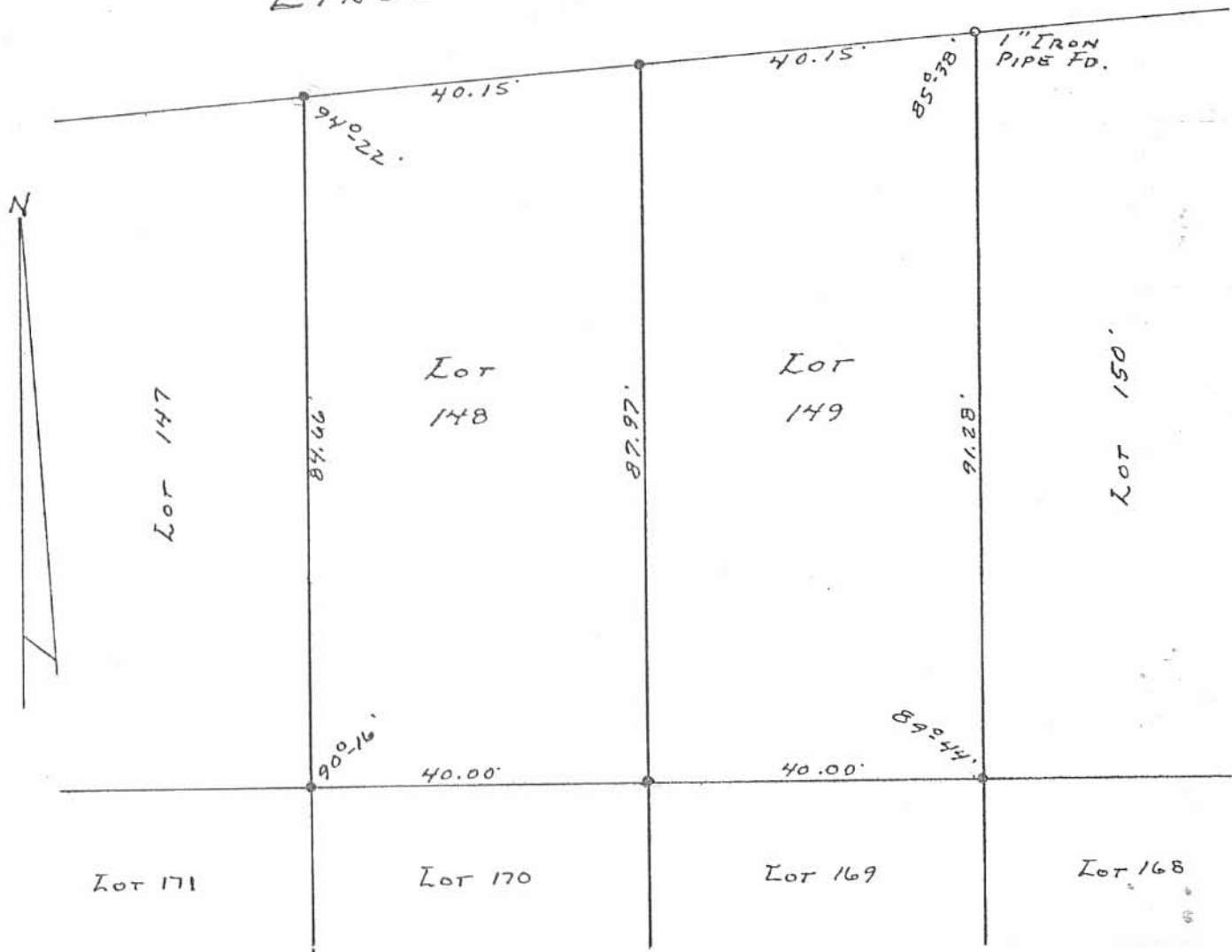

**Survey of Part of Lot No. 157
Wise Allotment of Island View**

The following described real estate situated in the Township of Stokes, County of Logan, State of Ohio and being a part of Lot No. 157 of the Wise Allotment of Island View as recorded in Plat Cabinet A, Slide 193 (5-31-1924) and being more particularly described as follows:

Beginning at a 5/8" x 30" Rebar set at the northwest corner to said Lot No. 157 and the northeast corner to Lot No. 156 of said Wise Allotment of Island View and in the south line of Lindenwood Avenue (30 feet wide);

Thence with the north line of Lot No. 157 and the south line of Lindenwood Avenue, N. 85°02'00" E. 32.82 feet to a 5/8" x 30" Rebar set, (Note: The north line of Lot No. 157 and the south line of Lindenwood Avenue is the Basis of Bearing for this survey - N. 85°02'00" E.);

Thence S. 12°26'00" E. 75.00 feet to a 5/8" x 30" Rebar set;

Thence S. 77°17'02" W. 32.21 feet to a 5/8" x 30" Rebar set in the west line of Lot No. 157 and the east line of Lot No. 156;

Thence with the line between Lots No. 156 and 157, N. 12°40'00" W. 79.42 feet to the place of beginning, containing 2,500.615 square feet or 0.057 Acres, more or less.

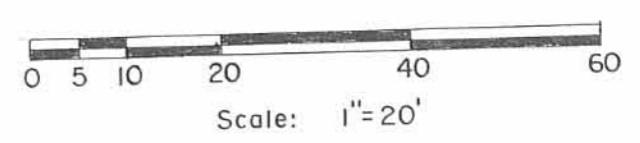
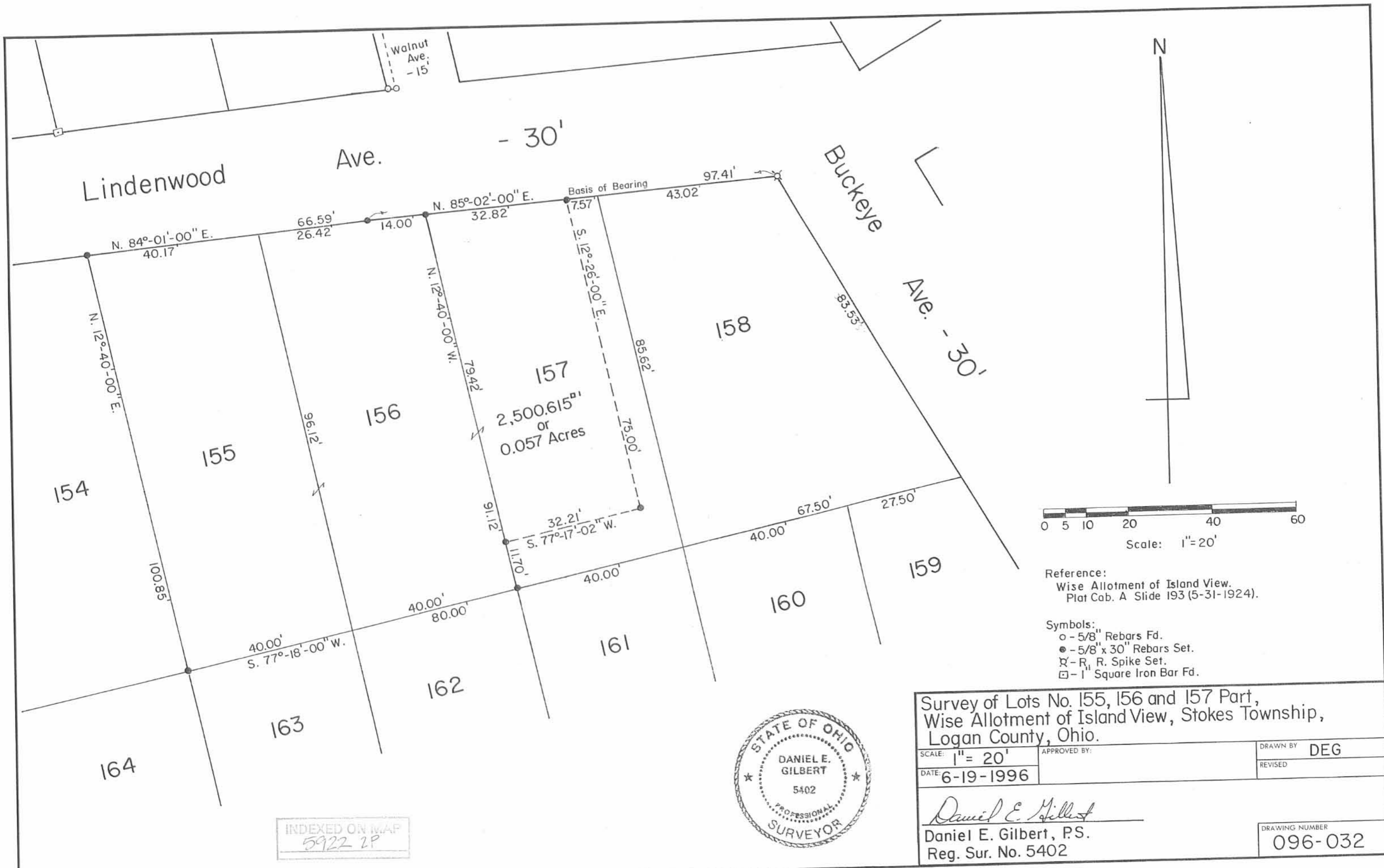
