The following described real estate situated in the State of Ohio, County of Logan, Township of Stokes, being part of the north half of the southwest quarter of Section 6, Town 7 S., Range 8 E. and more particularly described as follows:

Beginning at a cap and nail set in the centerline of County Highway 23 that is SOUTH 784.5 feet from the northwest corner of Daniel L. Burch, etal's 20 acre tract( Parcel A ) as described in O. R. Vol. 10 Page 143.

Thence EAST 365.92 feet to a 5/8 inch iron bar set, passing a 5/8 inch iron bar set at 30.00 feet.

Thence SOUTH 357.13 feet to a 5/8 inch iron bar set.

Thence WEST 365.92 feet to a cap and nail set in the centerline of said C. H. 23 and the west line of Section 6, passing a 5/8 inch iron bar set at 335.92 feet.

Thence with said centerline and section line NORTH 357.13 feet to the place of beginning.

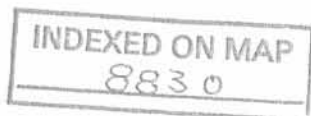
Containing 3.000 acres more or less, of which 0.246 acre is in the right of way of C. H. 23.

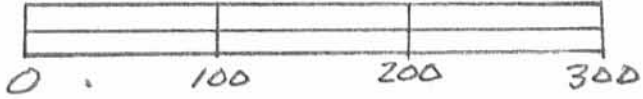
