Being the 10 foot alley between lots 71 and 72, commencing at the north line of Williams Street; thence northerly 150 feet to the south line of a 10 foot alley.

Being the 10 foot alley between lots 75 and 76, commencing at the north line of Williams Street; thence northerly 150 feet to the south line of a 10 foot alley.

Being the 10 foot alley adjacent to the north line of lots 71, 72, 73, 74, 75, 76, and 77, commencing at the west line of Center Street; thence westerly 427.5 feet to the west line of said Village of Lewistown.
