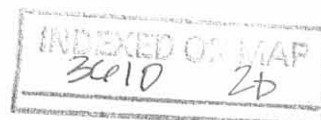
THENCE, with said north line, S 70°-38' W, a distance of 107.14 feet to the point of beginning. Containing 0.402 acre.
